ORDINANCE NO. 341-2023

AN ORDINANCE TO AMEND THE MOUNT JOY TOWNSHIP CODE OF ORDINANCES, CHAPTER 127, VEHICLES AND TRAFFIC, TO ESTABLISH TRAFFIC AND PARKING REGULATIONS ON A SEGMENT OF WESTBROOKE DRIVE.

BE AND IT IS HEREBY ORDAINED AND ENACTED by the Board of Supervisors of Mount Joy Township, Lancaster County, Pennsylvania, as follows:

Section 1. The Code of Ordinances of Mount Joy Township, Chapter 127, Vehicles and Traffic, Article II, Traffic Regulations, §127-16, Stop intersections, Subsection A, shall be amended by deleting the following stop intersection:

<u>Stop Sign On</u>	<u>Direction of Travel</u>	<u>At Intersection of</u>
Westbrooke Drive	North	Schwanger Road

Section 2. The Code of Ordinances of Mount Joy Township, Chapter 127, Vehicles and Traffic, Article II, Traffic Regulations, §127-16, Stop intersections, Subsection A, shall be amended by adding the following stop intersections in alphabetical order:

<u>Stop Sign On</u>	<u>Direction of Travel</u>	<u>At Intersection of</u>
Westbrooke Drive	Both	Schwanger Road
Westbrooke Drive	North	At intersection of Westbrooke Drive and Pin Tail Lane (private street)

Section 3. The Code of Ordinances of Mount Joy Township, Chapter 127, Vehicles and Traffic, Article III, Parking Regulations, §127-33, Parking prohibited at all times in certain locations, shall be amended to insert the following parking prohibitions in alphabetical order:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Westbrooke Drive	North	Between 801 Westbrooke Drive and 823 Westbrooke Drive
Westbrooke Drive	East	825 Westbrooke Drive to 833 Westbrooke Drive

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Westbrooke Drive	South	835 Westbrooke Drive to 853 Westbrooke Drive
Westbrooke Drive	Southwest	855 Westbrooke Drive to intersection with Westbrooke Drive

Section 4. All other sections, parts and provisions of the Mount Joy Township Code of Ordinances shall remain in full force and effect as previously enacted and amended.

Section 5. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance, it being the intent of the Board of Supervisors that the remainder of the Ordinance shall be and shall remain in full force and effect.

Section 6. This Ordinance shall take effect and be in force five (5) days after its enactment by the Board of Supervisors of the Township of Mount Joy as provided by law.
