NOTICE IS HEREBY GIVEN that at a meeting of **Morrisville Borough Council**, to be held on December 20th at Morrisville Borough Hall, 35 Union Street, Morrisville, PA 19067, at 7:00 PM, Borough Council will consider, and if appropriate, enact, an Ordinance, the title and a summary of which are as follows:

AN ORDINANCE OF THE BOROUGH OF MORRISVILLE, BUCKS COUNTY, PENNSYLVANIA, LEVYING A TAX ON REAL PROPERTY LOCATED IN MORRISVILLE BOROUGH FOR FISCAL YEAR 2023 TOTALING UP TO 54.50 MILLS; REPEALING ALL INCONSISTENT ORDINANCES; PROVIDING A REPEALER CLAUSE, SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

The proposed ordinance establishes the property tax rate for the Borough of Morrisville for fiscal year 2023 up to 54.50 mills on each \$1.00 of assessed valuation; designates the breakdown for the millage for specific Borough purposes; and includes a severability and repealer clause as well as an effective date.

ORDINANCE NO. 1042

AN ORDINANCE OF THE BOROUGH OF MORRISVILLE, BUCKS COUNTY, PENNSYLVANIA, LEVYING A TAX ON REAL PROPERTY LOCATED IN MORRISVILLE BOROUGH FOR FISCAL YEAR 2023 TOTALING 54.50 MILLS; REPEALING ALL INCONSISTENT ORDINANCES AND RESOLUTIONS; PROVIDING A REPEALER CLAUSE, SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Council of the Borough of Morrisville, Bucks County, Pennsylvania is authorized to levy a tax on real property located within the Borough pursuant to the Borough Code [Act 37 of 2014, P.L. 432 (April 18, 2014)], as amended, at Section 1302, 8 Pa.C.S.A. § 1302; and

WHEREAS, the Council of the Borough of Morrisville, finds it necessary for the health, safety and welfare of the Borough to levy a tax as outlined herein.

NOW, THEREFORE, be it, and it is hereby **ORDAINED** by the Borough Council of the Borough of Morrisville, and it is hereby **ENACTED** and **ORDAINED** by authority of same as follows:

SECTION I. LEVYING OF REAL ESTATE TAX

A tax shall be levied on all real property within the Borough of Morrisville for the calendar year commencing January 1, 2023 as follows:

Purpose	Tax on each dollar of assessed valuation (mills)
FOR GENERAL BOROUGH PURPOSES	<u>35.00</u> Mills
FOR STREET LIGHTING	<u>2.00</u> Mills
FOR FIRE PROTECTION	<u>4.00</u> Mills
FOR RECREATION FUND	<u>4.50</u> Mills
FOR LIBRARY	<u>3.50</u> Mills
FOR STREET FUNDING	<u>2.00</u> Mills
FOR DEBT SERVICE	<u>1.00</u> Mills
FOR EMERGENCY MEDICAL SERVICES:	<u>2.00</u> Mills
FOR PENSION AND ANNUITY:	<u>.50</u> Mills
TOTAL:	<u>54.50</u> Mills

SECTION II. REPEALER

All Ordinances and Resolutions or parts of Ordinances and Resolutions inconsistent herewith are hereby repealed.

SECTION III. SEVERABILITY CLAUSE

Should any section, paragraph, sentence, clause or phrase in this Ordinance be declared unconstitutional or invalid for any reason, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and effect, and for this reason the provisions of this Ordinance shall be severable.

SECTION IV. EFFECTIVE DATE

This Ordinance shall be effective as of January 1, 2023.




