## VILLAGE OF MOUNT HOREB ORDINANCE 2024-10

## AN ORDINANCE TO AMEND SECTION 12.01(8) CIGARETTES, TO INCLUDE TOBACCO PRODUCTS AND ELECTRONIC VAPING DEVICES

The Village Board of the Village of Mount Horeb, Wisconsin, do ordain as follows:

Chapter 12.01 of Mount Horeb Code of Municipal Ordinances is amended as follows (**changes in bold**):

## 12.01 - LICENSE OR PERMIT REQUIRED.

A license or permit shall be required for each of the following businesses or activities at the indicated license or permit fee, which shall be for one year, unless otherwise indicated:

- (1) AMUSEMENT AND MUSIC DEVICES (Section 12.09). \$20.
- (2) AMUSEMENTS AND SHOWS, PUBLIC (Section 12.04).
  - (a) <u>Carnivals</u>. \$20 per day.
  - (b) All Other Shows. \$20 per day.
- (3) DIRECT SELLERS.
  - (a) \$20.00 for one week permit
  - (b) \$40.00 for one month permit
  - (c) \$100.00 for one year permit
- (4) DOG LICENSES. See Ch. 174, Wis. Stats.
- (5) FERMENTED MALT BEVERAGES. (§ 12.03).
  - (a) Class A retailer's license.
  - (b) Class B retailer's license.
  - (c) Temporary Class B ("picnic") license.
  - (d) License for less than 12 months.
  - (e) Provisional license.
- (6) INTOXICATING LIQUOR. (§ 12.03).
  - (a) Retail Class A license.
  - (b) Retail Class B.
  - (c) Reserve retail Class B license.

- (d) Temporary Class B ("picnic") license.
- (e) Retail Class C license.
- (f) License for less than 12 months.
- (g) Provisional License.
- (7) Alcohol operator's license.
  - (a) Provisional license. See § 125.17(5), Wis. Stats.
- (8) CIGARETTE, **TOBACCO PRODUCT, ELECTRONIC VAPING DEVICE** SALES. See § 134.66, Wis. Stats.
- (9) TAXICABS: TAXICAB BUSINESS LICENSE; TAXICAB OPERATOR'S PERMIT.

This ordinance shall take effect and be in full force after its passage and publication as required by law.
