## AN ORDINANCE TO AMEND SECTION 720.040(A)(2): OPERATION, MAINTENANCE AND **REPLACEMENT FUND AND TO ALSO AMEND SECTION 720.060(B): USER CHARGE RATES-HOW DETERMINED-APPLICATION BOTH OF TITLE VII. UTILITIES, CHAPTER** 720: USER CHARGE SYSTEM-SEWER OF THE MUNICIPAL CODE OF THE CITY OF MOUND CITY.

## NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF **MOUND CITY, MISSOURI, as follows:**

Section 1: Section 720.040(A)(2): Operation, Maintenance and Replacement Fund of Title VII. Utilities, Chapter 720: User Charge System-Sewer of the Municipal Code of the City of Mound City, Missouri is amended as follows:

SECTION 720.040(A)(2). The Replacement Account shall be an account designed for the purpose of ensuring replacement needs over the useful life of the sewer system. Deposits in the Replacement Account shall be made monthly from the replacement revenue in the amount of Sixty-five thousand dollars (\$65,000.00) annually.

Section 2: Section 720.060(B): User Charge Rates-How Determined-Application of Title VII. Utilities, Chapter 720: User Charge System-Sewer of the Municipal Code of the City of Mound City, Missouri, is amended as follows:

SECTION 720.060(B): (Reference is made to Appendix A of this Chapter, on file in the City Clerk's office.) The minimum charge per month shall be six dollars forty cents (\$6.40). In addition each user shall pay a user unit charge for operation and maintenance including replacement of five dollars ten cents (\$5.10) per one thousand (1,000) gallons of water billed at five hundred ten hundred-thousandths of a cent (\$.00510) per gallon of water or fraction thereof as determined in the preceding Section.

Section 3: Severability. If any section, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional; by a decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 4: This Ordinance shall be in full force and effect from and after January 1, 2023.

- 2. The water service charge for service outside the corporate limits of Mound City, Missouri, shall be as follows:
  - a. Minimum charge per meter, the sum of ten dollars seventy-five cents (\$10.75).
  - b. In addition, each user shall pay a unit charge per one thousand (1,000) gallons of water, up to a total of eight thousand (8,000) gallons, of twelve dollars eight-five cents (\$12.85) billed at one thousand two hundred eighty-five hundred-thousandths of a cent (\$.01285) per gallon of water or fraction thereof as determined in the preceding Section.
  - c. For each additional gallon or fraction thereof over eight thousand (8,000) gallons, each user shall pay a unit charge per one thousand (1,000) gallons of water of seven dollars eighty-eight cents (\$7.88) billed at seven hundred eighty-eight hundred-thousandths of a cent (\$.00788) per gallon of water or fraction thereof as determined in the preceding Section.
- 3. The water service charge for wholesale service to Holt County Public Water Supply District #1 (PWSD) shall be as follows:
  - a. Nine thousand dollars (\$9,000) for the first (1st) one million two hundred thousand (1,200,000) gallons, which amount shall also be the minimum charge per month.
  - b. For the next six hundred thousand (600,000) gallons, the PWSD shall pay a unit charge per one thousand (1,000) gallons of water of seven dollars and zero cents (\$7.00) billed at seven thousandths of a cent (\$.00700) per gallon of water or fraction thereof as determined in the preceding Section.
  - c. For each additional gallon or fraction thereof over one million eight hundred thousand (1,800,000) gallons, the PWSD shall pay a unit charge per one thousand (1,000) gallons of water of six dollars and fifty cents (\$6.50) billed at sixty-five ten-thousandths of a cent (\$.00650) per gallon of water or fraction thereof as determined in the preceding Section.

**Section 4: Severability.** If any section, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional; by a decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 5: This Ordinance shall be in full force and effect from and after January 1, 2023.
