AN ORDINANCE ACCEPTING DEDICATION OF CERTAIN PUBLIC IMPROVEMENTS

WHEREAS, the Developer and Owners of Grindstone Grove, request the City of Moscow Mills, Missouri (the "City") to dedicate as City property and accept for maintenance the water lines, and sewer lines within Grindstone Grove located in Lincoln County, Missouri; (collectively, the "Public Improvements"); and

WHEREAS, the City has inspected the Public Improvements, and has determined they have been constructed in a manner consistent with the approved plans for construction and comply with the requirements and standards adopted by the City for such Public Improvements; and

WHEREAS, the City finds it is in the best interest of the City and its residents to dedicate the Public Improvements as City Property and to accept such Improvements for public maintenance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF MOSCOW MILLS, MISSOURI, AS FOLLOWS:

Section 1: That such improvements to be dedicated are specifically described as follows: The water lines and sewer lines within Grindstone Grove, described in attached Exhibit "A".

Section 2: All of the City's requirements for construction and dedication of Public Improvements having been met, the City of Moscow Mills, Missouri, accepts these Public Improvements as City Property and accepts such Public Improvements for public maintenance.

Savings Clause.


Except as expressly set forth herein, nothing contained in this ordinance shall in any manner be deemed or construed to alter, modify, supersede, supplant, or otherwise nullify any other ordinance of the city, or the requirements thereof, whether or not relating to or in any manner connected with the subject matter hereof.

Severability Clause.

If any term, condition, or provision of this ordinance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof shall be valid in all other respects and continue to be effective and each and every remaining provision hereof shall be valid and shall be enforced to the fullest extent permitted by law, it being the intent of the Board of Alderman that it would have enacted this ordinance without the invalid or unenforceable provisions. In the event of a subsequent change in applicable law so that the provisions which had been held invalid is no longer invalid, said provisions shall thereupon return to full force and effect without further action by the city and shall thereafter be binding.


