ORDINANCE 12-2023

AN ORDINANCE OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF MULLICA, COUNTY OF ATLANTIC, STATE OF NEW JERSEY, REPEALING ORDINANCE 9-2011 TITLED CREATING CHAPTER 6 "CONTRACTS" ESTABLISHING LIMITS ON POLITICAL CONTRIBUTIONS MADE BY THOSE INDIVIDUALS OR BUSINESS ENTITIES SEEKING TO OR PERFORMING BUSINESS WITH THE TOWNSHIP OF MULLICA

WHEREAS, pursuant to N.J.S.A. 40:48-2, a municipality may repeal an ordinance contrary to the laws of the state; and

WHEREAS, the Mayor and Committee of the Township of Mullica adopted Ordinance 9-2011, on August 9, 2011, Creating Chapter 6, "Contracts" Establishing Limits on Political Contributions Made by Those Individuals or Business Entities Seeking To or Performing Business with the Township of Mullica, setting the limit at \$10,000 as opposed to the \$17,500 limit pursuant to LFN 2023-14, released on August 8, 2023.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Committee of the Township of Mullica, County of Atlantic, State of New Jersey, that Ordinance 9-2011 Titled Creating Chapter 6 "Contracts," establishing limits on political contributions made by those individuals or business entities seeking to or performing business with the Township of Mullica is hereby repealed pursuant to LFN 2023-14, titled "Pay-to-Play Law Updates for Local Governments," attached hereto.

BE IT FINALLY ORDAINED, that this Ordinance shall take effect upon passage and publication in the manner required by New Jersey law.
