LOCAL LAW 2 OF THE YEAR 2021 providing for the amendment of the salary of Town Justice Matthew Green of the Town of Naples.

Be it enacted by the Town Board of the Town of Naples, County of Ontario, as follows:

Section 1: Short Title.

This Local Law shall be known as the "Town Justice Salary Amendment Law of 2021".

Section 2: Legislative Intent.

The purpose of this Local Law is to amend the 2021 salary of the Town Justice of the Town of Naples retroactive to January 01, 2021.

Section 3: Legislative Authority.

This Local Law is adopted pursuant to the provisions of the Municipal Home Rule Law (MHRL) of the State of New York and is subject to the permissive referendum provisions of Section 24 of said Law.

Section 4: Provisions: Modification of Salary of Elective Office of the Town Justice of the Town of Naples.

The salary of the Town Justice position currently occupied by Matthew Green is increased to \$25,000.00 retroactively to January 01, 2021 and shall continue at that rate so long as he remains the single Town Justice serving the Town of Naples. In the event that a second Town Justice is appointed or otherwise takes office the salary for the position presently occupied by Matthew Green shall revert to a salary of \$12,500.00 per year, prorated, upon such second Town Justice being sworn into such office.

Section 5:

This Local law is subject to Permissive Referendum pursuant to Municipal Home Rule Law Section 24.

Section 6: Effective Date.

This Local Law shall take effect immediately upon filing in the office of the Secretary of State of the State of New York in accordance with the provisions of the Municipal Home Rule Law, subsequent to having been duly adopted by the Town Board of the Town of Naples and the results of a referendum hereon having been certified by the Board of Elections of the County of Ontario that this Local Law was approved by the


electors of the Town of Naples, in the event that an appropriate petition requiring such referendum shall have been filed pursuant to MHRL Section 24 requiring such referendum.


