PROPOSED AMENDMENTS TO THE CODE OF THE VILLAGE OF NAPLES AMENDING CHAPTER 385 OF SAID CODE TO PROVIDE THAT ADULT USE CANNABIS CONSUMPTION ESTABLISHMENTS AND ADULT USE CANNABIS RETAIL ESTABLISHMENTS BE PERMITTED USES WITHIN THE C-1 AND C-3 COMMERCIAL ZONING DISTRICTS OF THE VILLAGE OF NAPLES

1. Article 385-19(A)(1) Commercial District Permitted Uses is hereby amended to add the following:

T. Adult Use Cannabis Retail Dispensary provided that the applicant complies with all licensing, set back, notification, and all other requirements set forth in the "Cannabis Law" of the State of New York as may be amended from time to time.

U. Adult Use Cannabis On-Site Consumption provided that the applicant complies with all licensing, set back, notification, and all other requirements set forth in the "Cannabis Law" of the State of New York as may be amended from time to time.

2. Article 385-21(C) Commercial Winery District Permitted Uses is hereby amended to add the following:

(8) Adult Use Cannabis Retail Dispensary provided that the applicant complies with all licensing, set back, notification, and all other requirements set forth in the "Cannabis Law" of the State of New York as may be amended from time to time.

(9) Adult Use Cannabis On-Site Consumption provided that the applicant complies with all licensing, set back, notification, and all other requirements set forth in the "Cannabis Law" of the State of New York as may be amended from time to time.
