ORDINANCE AMENDING SECTION 312-84, SCHEDULE XIII: PARKING PROHIBITED CERTAIN HOURS AND SECTION 312-79 SCHEDULE VIII: STOP INTERSECTIONS OF CHAPTER 312, VEHICLES AND TRAFFIC, OF THE CODE OF THE CITY OF NEW ROCHELLE (WINTHROP AVENUE).

BE IT ORDAINED by the City of New Rochelle:

Section 1. The Code of the City of New Rochelle, Section 312-84, Schedule XIII: Parking Prohibited Certain Hours, of Chapter 312, Vehicles and Traffic, is hereby amended as follows:

§ 312-84. Schedule XIII: Parking Prohibited Certain Hours.

In accordance with the provisions of § 312-40, no person shall park a vehicle between the hours listed upon any of the following described streets or parts of streets subject to winter suspension of alternate side of street sweeping parking regulations as denoted by an asterisk (*) herein:

Section 2. The Code of the City of New Rochelle, Section 312-79 Schedule VIII: Stop Intersections, of Chapter 312, Vehicles and Traffic, is hereby amended as follows:

§ 312-79 Schedule VIII: Stop Intersections.

In accordance with the provisions of § 312-34, the following described intersections are hereby designated as stop intersections, and stop signs shall be installed as follows:
