ORDINANCE AMENDING SECTIONS 267-3, CONDITIONS FOR ISSUANCE OF PERMIT, OF CHAPTER 267, SIDEWALK CAFES; SECTION 270-2, WORD USAGE; DEFINITIONS, SECTION 270-25, SIDEWALK PLANTERS AND OTHER FURNISHING ZONE ITEMS, OF CHAPTER 270, SIGNS: SECTION DEFINITIONS. 312-1. SECTION 312-50.2. **RESIDENTIAL PARKING PERMIT SYSTEM, SECTION 312-**53, PAYMENT, SECTION 312-54, FEES; OPERATION OF METERS: TIME LIMITATIONS, SECTION 312-55, OVERTIME PARKING PROHIBITED, SECTION 312-56, MANNER OF PARKING, SECTION 312-57, USE OF SLUGS OR SUBSTITUTES FOR COINS PROHIBITED, SECTION 312-58, COLLECTION OF METER MONEY, SECTION 312-59, DISPOSITION OF FUNDS COLLECTED, SECTION 312-60, **DESIGNATION OF PARKING-METER ZONES, SECTION 312-**62, PARKING LOTS, SECTION 312-65, AUTHORITY TO IMPOUND VEHICLES, SECTION 312-85, SCHEDULE XIV: TIME LIMIT PARKING, SECTION 312-96, SCHEDULE XXV: PARKING PERMIT ZONES FOR PUBLIC BUSINESS AT OR ADJACENT TO GOVERNMENT FACILITIES, OF CHAPTER 312. VEHICLES AND TRAFFIC; SECTION 331-159. OPERATIONS STANDARDS, OF CHAPTER 331, ZONING; AND SECTION 133-1, ENUMERATION OF FEES, OF CHAPTER 133, FEES, OF THE CODE OF THE CITY OF NEW ROCHELLE. (Rev.)

WHEREAS, Department of Development Staff recently conducted a review of the City Code sections associated with municipal parking, both on and off street; and

WHEREAS, based on this review, the Department of Development hereby recommends the following amendments to the current City Code to better manage the overall municipal parking operation; now, therefore

BE IT ORDAINED by the City of New Rochelle:

Section 1. Section 267-3, Conditions for issuance of permit, of Chapter 267, Sidewalks and Cafes, of the Code of the City of New Rochelle, is hereby amended to read as follows:

§ 267-3 Conditions for issuance of permit.

H. There shall be a minimum clear distance of five feet, exclusive of the area occupied by the sidewalk cafe, free of all obstructions, such as trees, parking meters/pay machines, utility poles, streetlights, benches, planters, and movable railings in order to allow for adequate and safe pedestrian movement.

Section 2. Section 270-2, Word usage; definitions, of Chapter 270, Signs, of the Code of the City of New Rochelle, is hereby amended to read as follows:

§ 270-2. Word usage; definitions.

B. Defined phrases. As used in this chapter, the following terms shall have the meanings indicated:

#### FURNISHING ZONE

The Furnishing Zone establishes an area for the placement of parking fee meters/pay machines, street signage, streetlighting, bike racks, refuse receptacles, street trees and bioretention areas, planters, approved structures and transit stop waiting and enclosure areas.

§ 270-25. Sidewalk Planters and Other Furnishing Zone Items.

A. Size and Positioning of Planters. A permit for a planter or other furnishing zone items may only be issued to the owner or the tenant of a building in a zoned district permitting such use and abutting the public sidewalk adjacent thereto, provided that the following requirements are met:

(2) The area to be used for the planter or other furnishing zone item must not extend beyond the extension of the side property lines onto abutting properties nor impede access to crosswalks, fire hydrants, parking meters/pay machines or other street placements installed by the City of New Rochelle.

Section 3. Section 312-1, Definitions, of Chapter 312, Vehicles and Traffic, of the Code of the City of New Rochelle, is hereby amended to read as follows:

#### § 312-1 Definitions.

B. The following words and phrases, which are not defined by Article 1 of the Vehicle and Traffic Law of the State of New York, shall have the meanings respectively ascribed to them in this section for the purposes of this chapter:

PARKING METER/PAY MACHINES ZONES

Such highways or parts of highways in the City where, pursuant to this chapter or any other ordinance, parking meters/pay machines are installed, operated, maintained, policed and supervised and where the payment of a fee for the privilege of parking where such meters/pay machines are in operation is fixed and required.

§ 312-50.2. [Residential parking permit system] On-Street Residential Parking Permits.

D. Issuance of residential parking permits.

(1) Upon application and payment of the applicable fee on the City's online permit system, any person who is a resident and who meets the applicable requirements of this section shall be issued one valid residential parking permit for each vehicle registered in the applicant's name and up to two guest passes per household within the residential parking permit area. The Department of Development shall establish guidelines to issue residential parking permits and guest passes, including proof of residency. Residential parking permits and guest passes shall be valid for one <u>calendar</u> year <u>and must be</u> renewed annually before the permit and guest pass expire.

(3) [If a guest pass is damaged such that it must be replaced, the resident, upon application therefore, shall be issued a replacement. The Department of Development may require proof of the damaged guest pass before a new one is issued.] In the event of the loss or destruction of any parking permit, the Department of Development shall issue a new one upon signing of an affidavit by the permittee as to the loss or destruction of the original parking permit for a fee as set forth in Chapter 133, Fees. In the event the permit was stolen, the fee will be waived upon the furnishing of a copy of a Police Incident Report.

(4) In the event the annual permit/guest pass fee is not paid in full within five (5) business days of the commencement of the period for which the permit has been applied for, a late payment charge equal to five percent (5%) of the annual fee will be imposed.

(5) <u>Changing a permit because of a new vehicle, new license plate, or for adding a vehicle is free if completed on-line. If changes are made in person, there is a \$20 administrative fee. Administrative Fee waivers are available to permit holders who have demonstrated a hardship.</u>

(6) If payment is made by check, and it is returned for any reason, applicant must pay the returned check fee of \$20.00.

(7) Permittees will not be notified as to the expiration of each term and shall be required to forward to the Department of Development the renewal a minimum of two weeks before the date of expiration. Permittees shall be required to file a new application upon changing the vehicle, any other change required in the application form and upon renewal. Renewal payment, if made by mail, is to be by check or money order.

(8) A parking permit issued under this Chapter shall be displayed by either hanging from the rear-view mirror in the City-issued hangtag or on the dashboard near the vehicle registration at all times when parked in an authorized space, and in such a manner that the entire face of the parking permit is visible from the outside of the vehicle.

(9) Parking without displaying the permit is subject to a summons.

(10) The permit shall not be altered or duplicated. Display of an altered or duplicated permit is subject to summons.

(11) The permittee shall be required to obey all other rules and regulations of the City of New Rochelle.

E. Fees.

(1) The fee for each residential parking permit and guest pass shall be \$25 <u>each</u>, or as set by resolution of the City Council from time to time and in Chapter 133, Fees.

F. Nonresident parking exception. Notwithstanding anything to the contrary herein, vehicles without a residential parking permit or guest pass issued pursuant to this section may be parked within the residential parking permit area for a period not in excess of 90 minutes except holidays.

#### § 312-53. Payment.

A. Except as set forth in Subsection B below, where parking meters/pay machines are installed in parts of streets and highways and except in an emergency or in compliance with the directions of a peace officer or traffic control signal or sign, no vehicle shall be parked between the hours of 8:00 a.m. and 6:00 p.m., Monday to Saturday, Sundays and holidays excepted, on all streets and highways, within a parking space alongside of or next to which a parking meter/pay machine is located, except upon payment of the required fee, except that commercial vehicles shall be allowed to occupy space without the payment of said fee while actually loading or unloading. The time limit in parking meter/pay machine areas is one hour except when otherwise designated.

§ 312-54. Fees; operation of meters; time limitations.

- A. Where parking meters/pay machines are installed on the streets and highways of the City, parking is permitted for two hours where meters/pay machines are installed, for a fee as set forth in Chapter 133, Fees.
- B. When any vehicle shall be parked in any space alongside of or next to which a parking meter/pay machine is located, the operator or driver of said vehicle shall, upon entering said parking space, immediately deposit in the parking meter/pay machine alongside of or next to said parking space the required fee in coin of the United States as the case may be for parking and shall operate the handle necessary to start operation of the said meter/pay machine, if such meter/pay machine is manually operated; and said parking space may then be used by such vehicle during the parking limit provided for the part of the highway in which said parking space is located. If any vehicle shall remain parked at any such parking space beyond the time allowed by regulation posted on the meter/pay machine or on official signs, such vehicle shall be considered as parked overtime, and the parking of a vehicle overtime or beyond the period of time permitted in any such part of a highway where a meter/pay machine is located shall be deemed a violation of this article.
- C. The parking of any motor vehicle at a parking meter/pay machine for more than the parking limit indicated on the meter/pay machine or an official sign is prohibited. The parking of any motor vehicle for more than the parking limit, regardless of whether or not the parking meter/pay machine at which such vehicle may be parked displays an overtime signal, shall be prima facie evidence that such vehicle is parked in violation.

#### § 312-55. Overtime parking prohibited.

A. It shall be unlawful and an offense for any person to permit a vehicle to remain parked in any parking space alongside of or next to which any parking meter/pay machine is placed while said meter/pay machine is displaying a signal showing that such vehicle shall have already parked beyond the period of time fixed by this chapter or any other ordinance of the City for such parking space.

§ 312-56. Manner of parking.

It shall be unlawful and an offense to park any vehicle across any line or mark designating the parking space for which a meter/pay machine is to be used, where lines or marks exist, or to park said vehicle in such way that the same shall not be within the area so designated by such lines or markings, if such lines or marks exist.

§ 312-57. Use of slugs or substitutes for coins prohibited.

It shall be unlawful and an offense to deposit or cause to be deposited in any parking meter/pay machine any slug, device or substitute for a coin of the United States.

§ 312-58. Collection of meter money.

It shall be the duty of the Commissioner of Finance to prescribe the method for causing regular collections of such moneys deposited in parking meters/pay machines. The Treasurer shall deposit or cause the moneys collected from said meters to be deposited to the credit of the City of New Rochelle. The control, operation, maintenance and supervision of the parking meters/pay machines shall be under the supervision and jurisdiction of the Commissioner of [Public Works] Development or duly appointed designee.

§ 312-59. Disposition of funds collected.

The coins required to be deposited as provided herein are hereby levied as fees for police regulation and inspection and to cover the cost of installation, operation, maintenance, policing and supervision of parking meters/pay machines and parking meter/pay machine zones and the enforcement of the provisions of this article.

§ 312-60. Designation of parking-meter/pay machine zones.

The streets or parts of streets described in Schedule XXIII (§ **312-94**), attached to and made a part of this chapter, are hereby designated as parking-meter/pay machine zones, and any person who shall park in any zone so designated shall comply with the provisions of this article.

§ 312-62. Parking lots.

C. The following parking lots operated by the City of New Rochelle are hereby established:

day. Parking shall be permitted in other portions of this lot full time in designated spaces upon the display of a permit available by mail or in person from the Department of Development at a rate as set forth in Chapter 133, Fees.]

[Parking shall be permitted in portions of this lot at a rate as set forth in Chapter 133, Fees, for a period not to exceed one, three, or 12 hours, depending upon meter used, 24 hours a day. Parking shall be permitted in other portions of this lot full time in designated spaces upon the display of a permit available by mail or in person from the Department of Development at the rate as set forth in Chapter 133, Fees. Overnight parking of commercially licensed vehicles is permitted pursuant to § 312-43A and D.]

Parking shall be permitted in portions of this lot at a rate as set forth in Chapter 133, Fees, from the hours of 8:00 a.m. to 6:00 p.m. Monday through Saturday for a period not to exceed three hours, and from the hours of 6:00 p.m. to 8:00 a.m. Monday through Saturday for a period not to exceed 14 hours, except Sundays and holidays.

[Parking shall be by permit only, available by mail or in person from the Department of Development pursuant to an annual fee as set forth in Chapter **133**, Fees.] Parking shall be permitted in portions of this

lot at a rate as set forth in Chapter 133, Fees, from the hours of 8:00 a.m. to 6:00 p.m. Monday through Saturday for a period not to exceed three hours, and from the hours of 6:00 p.m. to 8:00 a.m. Monday through Saturday for a period not to exceed 14 hours, except Sundays and holidays.

Parking shall be permitted in portions of this lot at a rate as set forth in Chapter 133, Fees, from the hours of 8:00 a.m. to 6:00 p.m. Monday through Saturday for a period not to exceed three hours, and from the hours of 6:00 p.m. to 8:00 a.m. Monday through Saturday 2

for a period not to exceed 14 hours, except Sundays and holidays. Parking shall be permitted in other portions of this lot fulltime, in designated spaces, upon the display of a permit available online, by mail or in person from the Department of Development at the rate as set forth in Chapter 133, Fees. Parking shall be permitted in portions of this lot at a rate as set forth in Chapter 133, Fees, from the hours of 8:00 a.m. to 6:00 p.m. Monday through Saturday for a period not to exceed three hours, and from the hours of 6:00 p.m. to 8:00 a.m. Monday through Saturday for a period not to exceed 14 hours, except Sundays and holidays. Parking shall be by permit only via Valet parking, available online, by mail or in person from the Department of Development pursuant to an annual/semiannual fee as set forth in Chapter 133, Fees.

E. Rules and regulations pertaining to parking in all City-operated parking lots or structures shall be as follows:

(3) The use of vehicle/motorcycle covers is prohibited in any City-owned Municipal facility and will be subject to tow-away regulations.

(4) Any motor vehicle/motorcycle parked in a City-owned parking facility must be legally registered and inspected. Vehicle registration and inspection must be visible at all times.

(10) Permittees in all City-operated parking facilities shall be subject to the following rules and regulations pertaining to parking permits:

(c) Purchase of multiple permits shall be based on availability. <u>Maximum two (2) permits</u> per household permitted.

(d) An official receipt and a permit listing license number(s) of vehicle(s) will be issued by the Department of Development upon payment of the fee(s).

(e) Permit renewals are not automatic and are subject to availability.

(f) Permittees will not be notified as to the expiration of each term and shall be required to forward to the Department of Development the renewal a minimum of two weeks

before the date of expiration. Permittees shall be required to file a new application upon changing the vehicle, any other change required in the application form and upon

renewal. Renewal payment, if made by mail, is to be by check or money order. (g) The City of New Rochelle does not guarantee that a parking permit will be available

or issued upon proper completion of an application.

(h) Every permit shall have printed or recorded in ink thereon the following:

[1] 1. The name of the parking area where the space is assigned.

[2] 2. The number of the parking bay assigned, if applicable.

[3] 3. The period for which the sticker is issued.

[4] 4. The number of the permit.

 (i) A parking permit issued under this Chapter shall be displayed by either hanging from the rear view mirror in the City-issued hangtag or on the dashboard near the vehicle registration at all times when parked in an authorized space, and in such a manner that the entire face of the parking permit is visible from the outside of the vehicle.
 (i) (Received)

(j) (Reserved)

(k) Parking without displaying the permit is subject to a summons.

(1) The permit shall not be altered or duplicated. Display of an altered or duplicated permit is subject to summons.

(m) In the event of the loss or destruction of any parking permit, the Department of Development shall issue a new one upon signing of an affidavit by the permittee as to the loss or destruction of the original parking permit for a fee as set forth in Chapter 133, Fees. In the event the permit was stolen, the fee will be waived upon the furnishing of a copy of a Police Incident Report.

(n) A permit is a revocable license subject to termination at the City of New Rochelle's discretion.

(o) Permission for parking is granted subject to the rights of the City of New Rochelle to cancel, in which case provision shall be made for the refund for the unexpired rental term. Refunds shall be made for only the following reasons, as per City Administrative Regulation No. 3.72. Any person currently issued a valid parking permit may submit a written request for a prorated refund of the unused portion of the parking permit fee paid. Refund requests must be sent to the City's Public Properties and Parking Manager. Refunds will be issued upon submission of a completed Refund Request Form and will be prorated based on whole months remaining on the permit. For example, a refund requested any time of any month would be prorated effective the start of the next month; however, the parking permit will be terminated based on the termination request date provided on the Refund Request Form. Annual permits will be issued a refund for the prorated monthly rate of the annual permit cost and semiannual permits will be issued a refund for the prorated monthly rate of the semiannual permit cost. Please note that any refund issued will terminate the parking permit. In the event that a permit is requested in the future by the refunded permit holder, the permit holder will be waitlisted if such a list exists at the time of application.

(p) The permittee shall be required to obey all other rules and regulations of the City of New Rochelle.

(q) Any vehicle unlawfully parked is subject to tow-away regulations.

(r) Motorcycle and motor scooter parking permits shall be issued only for the Intermodal Transportation Center Garage, the New Roc Parking Garage, and the Prospect Street Parking Lot, for parking in specially designated areas of such parking facilities at the annual parking permit fee set forth in Chapter 133, Fees, of the City Code. Motorcycle and motor scooter parking permits shall be issued to the owner of the vehicle and shall be affixed to and used only for such vehicle.

(s) A 10% discount for all residents who are senior citizens aged 65 and older shall apply

to all parking permits effective January 1, 2016. Such residents must submit proof of residency with the resident's name and address on it, a copy of the driver's license showing the resident's name and address on it, and the vehicle registration with the resident's name and address on it.

(t)In the event the annual or semi-annual fee is not paid in full within five (5) business days of the commencement of the period for which the permit has been applied for, a late payment charge equal to five percent (5%) of the annual or semi-annual fee will be imposed. If a permit lapses, you are unable to re-apply for a new permit in the same location until an entire renewal period has passed.

(u) Changing a permit because of a new vehicle, new license plate, or for adding a vehicle is free if completed on-line. If changes are made in person, there is a \$20 administrative fee. Administrative Fee waivers are available to permit holders who have demonstrated a hardship.

§ 312-65. Authority to impound vehicles.

- A. When any vehicle/<u>motorcycle/bicycle/scooter</u> is parked or abandoned on any highway or public parking lot within this City during a snowstorm, flood, fire or other public emergency which affects that portion of the public highway or parking lot upon which said vehicle is parked or abandoned, said vehicle may be removed by or under the direction of the Commissioner of Police.
- B. When any vehicle/<u>motorcycle/bicycle/scooter</u> is found unattended on any highway or public parking lot within the City where said vehicle constitutes an obstruction to traffic or an unsafe road condition, said vehicle may be removed by or under the direction of the Commissioner of Police.
- C. Tow-away zones. In addition to any other penalty provided for parking, stopping or standing in prohibited areas, the Police Commissioner or the Commissioner of Public Works, or both, are hereby empowered to remove or to direct the removal of any vehicle/motorcycle/bicycle/scooter or trailer, provided that signs are posted designating such streets as tow-away zones. All vehicle/motorcycle/bicycle/scooter or trailer removed from such tow-away zones may be redeemed, as provided for in this article.
- D. In addition to any other penalty provided for prohibited or unlawful parking in this chapter, the Police Commissioner is hereby empowered to remove or to direct the removal of any vehicle/motorcycle/bicycle/scooter or trailer that is parked for more than 48 continuous hours on any street or public place. All vehicles removed pursuant to the provisions of this section may be redeemed as provided for in this article, upon payment of the necessary expenses of removal and storage.
- E. The following additional vehicles are subject to towing:
  (1) Any vehicle/motorcycle/bicycle/scooter or trailer which is involved in an accident where the driver or owner is not at the scene or is incapable of making a decision or refuses to have the vehicle/motorcycle/bicycle/scooter or trailer moved from the accident location.
  - (2) Any vehicle/motorcycle/bicycle/scooter or trailer the owner of or registrant of who

has been issued at least 10 parking summonses in the City of New Rochelle which remain unpaid.

(3) Any vehicle/<u>motorcycle/bicycle/scooter or trailer</u> which is unattended and is parked in a hazardous manner or in a highly restricted location, i.e., fire zone, tow-away zone or blocked driveway.

(4) Any vehicle/<u>motorcycle/bicycle/scooter or trailer</u> which is derelict or abandoned as defined herein or is a stolen vehicle/<u>motorcycle/bicycle/scooter or trailer</u>.

(5) Any vehicle/motorcycle/bicycle/scooter or trailer which, after having been issued at least five parking summonses in the City of New Rochelle which remain unpaid 60 days following issuance of the oldest summons thereof, has been subject to booting pursuant to § **312-65.1** hereof and such open parking summonses have not all been paid within 24 hours of such booting.

(6) Any vehicle/<u>motorcycle/bicycle/scooter or trailer</u> which is parked on any off-street property owned or controlled by the City of New Rochelle, except where such parking is specifically permitted in public parking lots and garages pursuant to Article **VII** hereof.

Section 4. Section 331-159, Operation Standards, of Chapter 331, Zoning, of the Code of the City of New Rochelle, is hereby amended to read as follows:

§ 331-159. Operations Standards.

B. Valet Operators may use public parking either on-street or in an off-street facility. The use of on-street parking shall be specifically marked for valet operations by having a limited number of on-street meters/pay machines located in front of an eligible business be bagged only during a specified timeframe in order to protect the public health and safety by promoting the most efficient and safest flow of traffic in furtherance of the purposes of this Article.

Section 5. Section 133-1, Enumeration of fees, of Chapter 133, Fees, of the Code of the City of New Rochelle, is hereby amended to read as follows:
