## **ORDINANCE NO. 857**

AN ORDINANCE OF THE TOWNSHIP OF NETHER PROVIDENCE, COUNTY OF DELAWARE, AMENDING THE CODE OF NETHER PROVIDENCE TOWNSHIP, CHAPTER 243 - VEHICLES AND TRAFFIC, ARTICLE VI, MISCELLANEOUS PROVISIONS AT SECTION 243-35 SCHEDULE III, SECTION B: PROHIBITED LEFT TURNS FROM STACKHOUSE LANE ONTO PROVIDENCE ROAD BETWEEN 7:00 AM AND 9:00 AM MONDAY THROUGH FRIDAY

The Board of Commissioners of Nether Providence Township, Delaware County, Pennsylvania, does hereby ENACT and ORDAIN the following.

## SECTION 1. SECTION 243-35 SCHEDULE III, SECTION B: PROHIBITED TURNS.

The following prohibited turns section is hereby amends the prior turn restrictions established by Schedule III by adding the following location and restriction:

Name of Street Direction of Travel Prohibited On

Stackhouse Lane South Providence Road between 7:00 A.M. and 9:00 A.M.

Monday through Friday

<u>SECTION 2</u>. In accordance with the provisions of the Vehicle and Traffic Code at § 243-35, Schedule III Section B is hereby amended to provide that no person shall make a left turn from Stackhouse Lane on the Strath Haven Middle School property onto southbound Providence Road between 7:00 AM and 9:00 AM, Monday through Friday.

SECTION 3. Severability. That if any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance. The Commissioners of the Township of Nether Providence hereby declare that it would have passed this Ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

<u>SECTION 4</u>. **Savings Clause**. That nothing in this Ordinance hereby adopted shall be construed to affect any other suit or proceeding pending in any court or any rights acquired or liability incurred, or any cause or causes of action acquired or existing, nor shall any just legal right or remedy of any character be lost, impaired or affected by this Ordinance.

<u>SECTION 5</u>. **Immediate Effect**. That this Ordinance and rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect immediately from and after the date of its final passage and adoption.
