LOCAL LAW # 3 OF 2021

TOWN OF NEW BERLIN

A LOCAL LAW REGARDING THE RESIDENCY REQUIREMENTS FOR TOWN POLICE OFFICERS

Be it enacted by the Town Board of the Town of New Berlin as follows:

Section 1. This Local law will repeal and replace Local Law #2 of 2016

Section 2. This is a local law to include the position of Town Police Officer to those individuals who may be hired by the Town, but who reside outside of the Town. This local law is an addition to the provisions of Chapter 51 of the Code of the Town of New Berlin.

Section 3. Chapter 51 of the Town of New Berlin Municipal Code is hereby amended by the inclusion of a new §51-3 entitled "Police Officers", which shall read, "The position of Town Police Officer may be filled by a resident of the Town of New Berlin, or a resident of the County of Chenango and adjoining Counties, as well as Herkimer and Oneida Counties.

Section 4. This local law shall take effect upon filing in the office of the Secretary of State.
