

THE SAME BEING AN ORDINANCE OF THE CITY OF NEOSHO, MISSOURI, CANVASSING THE RETURNS OF THE MUNICIPAL ELECTION HELD TUESDAY, NOVEMBER 3, 2020, SUBMITTING TO THE QUALIFIED VOTERS OF SAID CITY, AN AMENDMENT TO SECTIONS 2.02, 2.14, 2.16 AND 9.05 OF THE CITY CHARTER AND ALLOWING FOR A SEVEN (7) PERSON COUNCIL AND DECLARING THE RESULTS THEREOF UNDER EMERGENCY MEASURE SO AS TO COMPLY WITH PROVISIONS OF THE CITY CHARTER.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NEOSHO, MISSOURI, AS FOLLOWS:

Section 1: It is found and determined that on November 3, 2020, the City of Neosho held and conducted a valid and proper Municipal Election for the purpose of amending the provisions of the City Charter.

Section 2: That after due and proper canvass of said returns and proper count and canvass of absentee ballots, the following are declared to be the official votes:

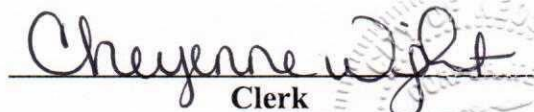

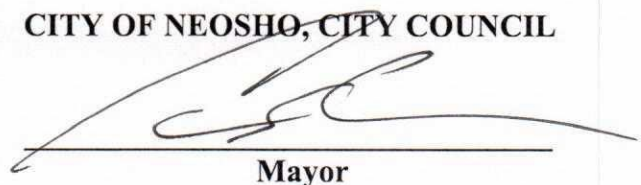
Section 5: This ordinance shall be in full force and effect upon final passage and approval.

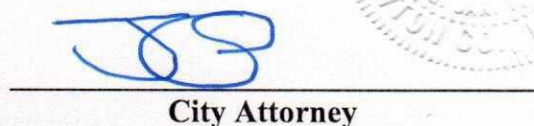
