ORDINANCE NO. 964

THE SAME BEING AN ORDINANCE OF THE CITY OF NEOSHO, MISSOURI, ADOPTING AND APPROVING THE 1977-1978 FISCAL YEAR BUDGET: AUTHORIZING THE EXPENDITURES AS THEREIN PROVIDED AND SET FORTH WITHIN THE LIMITS THEREIN PROVIDED: DIRECTING THAT A COPY OF SUCH BUDGET BE CERTIFIED AS APPROVED AND REMAIN ON FILE WITH THE CITY CLERK AS THE OFFICIAL BUDGET OF THE CITY: AND FIXING THE EFFECTIVE DATE THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEOSHO, MISSOURI, AS FOLLOWS:

SECTION ONE: The Council finds and determines that there has been presented to it by the City Manager and other officers of the City of Neosho a proposed budget for the fiscal year 1977-1978 and that the same has been carefully and exhaustively examined and considered by the City Council.

SECTION TWO: The Council declares that the proposed budget so presented is in all things satisfactory and that the same should be and it is hereby in all things approved and confirmed and adopted as the budget of the City of Neosho for the period aforesaid.

SECTION THREE: Expenses within the limits as set forth in said budget are hereby authorized to be made in accordance with the law and subject to the laws of the State of Missouri and ordinances of the City applicable thereto.

SECTION FOUR: It is ordained that the original of such budget be certified as approved by the Council, by the Mayor and the City Clerk and shall remain on file with the City Clerk as the official budget of the City from the date of July 1, 1977.

SECTION FIVE: This ordinance shall be in full force and effect immediately upon final passage and approval for the reason the same is deemed an emergency measure for the reason the City's fiscal year begins July 1.
