Chapter C. Charter Title XII. Assessment and Taxation

211. Notice of receiving taxes.

After the date of the tax warrant, the Receiver of Taxes shall publish a notice in the official newspaper once a week for two consecutive weeks and shall post such notice in three (3) public places, stating:

- 1. That he has received the warrant for collection of state, county and city taxes; and
- When the taxes are due and payable; and
