ORDINANCE NO. 2324
BOROUGH OF NORTH ARLINGTON
COUNTY OF BERGEN, NEW JERSEY

AN ORDINANCE TO AMEND CHAPTER 205 OF THE CODE OF THE
BOROUGH OF NORTH ARLINGTON ENTITLED "LAND DEVELOPMENT"


WHEREAS, the Mayor and Council have determined that there is a need to amend Chapter 205 of the Code of the Borough of North Arlington; and

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of North Arlington, County of Bergen, State of New Jersey, that Section 71(G) of Chapter 205 of the Code of the Borough of North Arlington entitled "Land Development" is hereby amended to read as follows:

Parking of commercial vehicles. In a residential zone, not more than one commercial vehicle owned or operated by a resident of the premises with a rated capacity of two tons or less may be kept on each lot. All commercial vehicles with a rated capacity of more than two tons are prohibited. The following commercial vehicles are prohibited regardless of size: box trucks, tractor trailers, trailers of any kind, dump trucks, construction equipment, tow trucks, flat beds, buses and any passenger vehicle with a capacity of more than 15 passengers.

IT IS FURTHER ORDAINED that the remainder of Chapter 205 of the Code of the Borough of North Arlington shall remain in full force and effect.
