ORDINANCE NO. 2396
BOROUGH OF NORTH ARLINGTON
BERGEN COUNTY, NEW JERSEY

AN ORDINANCE TO AMEND CHAPTER 30 OF THE CODE OF THE
BOROUGH OF NORTH ARLINGTON ENTITLED "FIRE DEPARTMENT"

WHEREAS, Chapter 30 of the Code of the Borough of North Arlington is entitled "Fire Department" and Section 2 of said chapter is entitled "Qualifications for Membership"; and

WHEREAS, N.J.S.A. 40A:14-68 provides that a municipality may set such terms and conditions as the municipality may deem proper for the operation of a municipal volunteer fire department; and

WHEREAS, after consultation with the Fire Department of the Borough of North Arlington, it is apparent that it is in the best interests of the Borough to expand the membership criteria as it pertains to the Fire Department of the Borough of North Arlington;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of North Arlington that §30-2(a)(2) of the North Arlington Borough Code shall be amended in its entirety to read as follows:

An applicant for membership may reside in North Arlington or any of the following contiguous communities:


- A. Lyndhurst, Bergen County, New Jersey.
- B. Kearny, Hudson County, New Jersey, but only those who reside within the geographic area between Belleville Turnpike to Quincy Avenue and Passaic Avenue to East of Schuyler Avenue.

In the event that a waiting list for applicants exists, preference will be given to residents of the Borough of North Arlington;

IT IS FURTHER ORDAINED that §30-2(c) of the Code of the Borough of North Arlington, entitled "Relocation of Firefighters", shall be deleted in its entirety; and

IT IS FURTHER ORDAINED that the remainder of Chapter 30 of the Code of the Borough of North Arlington shall remain in full force and effect.
