## ORDINANCE NO. 2403 BOROUGH OF NORTH ARLINGTON BERGEN COUNTY, NEW JERSEY

# AN ORDINANCE AMENDING CHAPTER 187 §13A OF THE CODE OF THE BOROUGH OF NORTH ARLINGTON ENTITLED "TRUCK PARKING HOURS RESTRICTED"

WHEREAS, on November 13, 2015, the Mayor and Council passed Ordinance No. 2170 amending Chapter 187 of the Code of the Borough of North Arlington entitled "Parking Regulations"; and

WHEREAS, on February 11, 2016, the Mayor and Council passed Ordinance No. 2180 further amending Chapter 187 of the Code of the Borough of North Arlington entitled "Parking Regulations"; and

WHEREAS, the Mayor and Council of the Borough of North Arlington have determined that there is a need to amend Chapter 187 §13A of the Code of the Borough of North Arlington entitled "Truck Parking Hours Restricted" of the Parking Regulations Code to permit street parking for certain persons using limousines, taxis and company sedans as their primary private vehicle; and

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of North Arlington, County of Bergen, State of New Jersey, that Chapter 187 §13A entitled "Truck Parking Hours Restricted" shall be amended to read as follows:

The owner or operator of any commercial truck, truck tractor, trailer, semitrailer or bus bearing commercial registration plates shall not park said vehicle on any street, avenue, lane, road or other public thoroughfare in the Borough of North Arlington between the hours of 11:00 p.m. and 6:00 a.m. (prevailing time). Commercial registration shall include, but not be limited to, regular commercial, constructor, dealer or omnibus plates. Commercial registration shall not include any sedan or car with, limousine or similar registration or plates, used by a resident of North Arlington as his or her principal means of private transportation (an "Exempted Vehicle"). Exempted Vehicles do not include taxis. Such Exempted Vehicles shall be limited to one per residence in North Arlington.

IT IS FURTHER ORDAINED that the remainder of Chapter 187 of the Code of the Borough of North Arlington shall remain in full force and effect; and

IT IS FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent herewith are hereby repealed; and

IT IS FURTHER ORDAINED that if any parts, sections, provisions, or the total of any of the above provisions are held to be invalid or unenforceable in any court, the findings or judgments of which court are applicable to the State of New Jersey, the balance and remainder of such provisions shall remain in full force and effect as an Ordinance of the Borough of North Arlington; and

IT IS FURTHER ORDAINED that this Ordinance shall become effective twenty (20) days after the adoption and publication according to law.
