**ORDINANCE NO. 2405
BOROUGH OF NORTH ARLINGTON
BERGEN COUNTY, NEW JERSEY**

**AN ORDINANCE AMENDING CHAPTER 54 OF THE CODE OF THE BOROUGH OF
NORTH ARLINGTON ENTITLED, "POLICE DEPARTMENT"**

WHEREAS, the North Arlington Chief of Police has requested an update to the North Arlington Police Department's overtime pay commensurate with recent pay increases given to the North Arlington Police Department's officers; and

WHEREAS, the North Arlington Mayor and Council had last adjusted the North Arlington Police Department's overtime pay schedule on September 19, 2010 by the adoption of Ordinance No. 2059

WHEREAS, the Mayor and Council have determined that it is therefore appropriate to amend Chapter 54 of the Code of the Borough of North Arlington entitled "Police Department," specifically Section 55 entitled "Overtime Billing;" and

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of North Arlington, County of Bergen, State of New Jersey, that subsection B of Chapter 54, Section 55 entitled "Overtime billing" is hereby amended to read as follows

- B. The rate for side-job overtime services provided by Borough officers shall be as follows: The rate of compensation to the Borough Police Officer wages shall be \$135 per hour, plus an administrative fee of \$5 per hour, plus a vehicle use fee of \$10 per hour, for a total rate detail fee of \$150 per hour.**

IT IS FURTHER ORDAINED that the remainder of Chapter 54 of the Code of the Borough of North Arlington shall remain in full force and effect; and

IT IS FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent herewith are hereby repealed; and

IT IS FURTHER ORDAINED that if any parts, sections, provisions, or the total of any of the above provisions are held to be invalid or unenforceable in any court, the findings or judgments of which court are applicable to the State of New Jersey, the balance and remainder of such provisions shall remain in full force and effect as an Ordinance of the Borough of North Arlington; and

IT IS FURTHER ORDAINED that this Ordinance shall become effective twenty (20) days after the adoption and publication according to law.
