A Local Law to amend the Code of the Town of North Salem by amending Chapter 220 entitled Vehicles and Traffic.

Be It Enacted by the Town Board of the Town of North Salem as follows:

1. Sections 220-6 and 220-22 entitled <u>Stop Intersections</u> is hereby amended to add the following:

Stop Sign On	Direction of Travel	At Intersection of
Hawley Road	South	Lost Pond Lane and Post Road
Hawley Road	North	Post Road and Lost Pond Lane
Post Road	East	Hawley Road
Lost Pond Lane	West	Hawley Road

2. <u>Effective Date</u>: this Local Law shall be effective immediately upon filing of same with the Secretary of State of the State of New York.
