

TOWNSHIP OF NORTH FAYETTE RESOLUTION NO. 70-24

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF NORTH FAYETTE, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE PROPER OFFICERS OF THE TOWNSHIP OF NORTH FAYETTE TO APPROVE, SUPPORT, AND SIGN THE PREPARED ROBINSON RUN ADVISORY GROUP SANITARY SEWER OVERFLOW ELIMINATION PLAN WITH THE ALLEGHENY COUNTY HEALTH DEPARTMENT CONCERNING ALLEGED SANITARY SEWER OVERFLOWS RELATED TO THE TOWNSHIP OF NORTH FAYETTE'S SANITARY SEWER SYSTEM.

WHEREAS, the Township of North Fayette (hereinafter "Township"), is a Municipal Corporation, duly organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Township of North Fayette (hereinafter the "Township") owns and/or operates a sanitary sewer system which conveys sanitary sewage and/or industrial waste from, within or through the Township's geographic borders directly or indirectly to sewage facilities owned and operated by the Allegheny County Sanitary Authority (hereinafter "ALCOSAN"); and

WHEREAS, the Allegheny County Health Department (hereinafter "ACHD") for itself and on behalf of the Commonwealth of Pennsylvania, Department of Environmental Protection and the United States Environmental Protection Agency (collectively, the "Regulatory Agencies") has presented the Township with a Consent Order and Agreement (hereinafter the "Consent Order") concerning the alleged Sanitary Sewer Overflows in or related to the Township's sanitary sewer system; and

WHEREAS, the Township entered into the Consent Order and Agreement with the Allegheny County Health Department on October 12, 2021 imposing on the Township certain obligations with respect to its sewer system; and

WHEREAS, as a condition of the Consent Order, the Township is required to develop and submit source flow reduction measures planned for the Township; and

WHEREAS, the communities located within the Robinson Run sewershed formed the Robinson Run Advisory Group which is comprised of representatives from the Township, the Township of South Fayette and the Municipality Authority of the Township of South Fayette, the Borough of McDonald and the McDonald Sewage Authority, and the Borough of Oakdale; and

WHEREAS, as required by the Consent Order, all respective Robinson Run Advisory Group municipalities shall develop a continuous simulation calibrated hydrologic and hydraulic model to identify causation of SSOs and complete an analysis with a chosen alternative with dates each SSO will be eliminated. Each municipality shall submit to ACHD with a copy to PADEP and ALCOSAN, the Alternative Analysis completed

under Paragraph 7.b of the Consent Order; and

WHEREAS, compliance with Phase II Consent Order Agreement for the Robinson Run Advisory Group is planned to be completed in conjunction with the ALCOSAN Regionalization transfer process as well as the North Fayette Township Act 537 Plan Special Study for the North Branch and Robinson Run Interceptor Improvements;

WHEREAS, all four of the Robinson Run Advisory Group municipalities choose to accept and support the report after Baseline Due Diligence evaluation of each municipality's system and the existing conditions therein;

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of North Fayette hereby resolves as follows, incorporating the above recitals by reference:

- The Board of Supervisors, by way of this Resolution and in compliance with Phase II of the Consent Order for the Robinson Run Advisory Group, approves the engineering evaluations contained in the Source Flow Reduction/Sanitary Sewer Overflow Elimination Plan report.
- SECTION 2. The members of the Board and the Township are hereby authorized and directed, in the name and on behalf of the Township, to execute or cause to be executed the Source Flow Reduction/Sanitary Sewer Overflow Elimination Plan report in accordance with the intent and purpose of this Resolution.
- **SECTION 3.** All prior resolutions are hereby repealed in whole or in part to the extent inconsistent herewith.
- SECTION 4. This Resolution shall take effect immediately.

AND NOW, this 25th day of June 2024, upon motion duly made and seconded, the foregoing **RESOLUTION** is hereby adopted.
