



**TOWNSHIP OF NORTH FAYETTE  
RESOLUTION NO. 87-24**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF NORTH FAYETTE, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, APPOINTING BRANDON SPENCER TO THE POSITION OF INSPECTOR, FIRE PREVENTION, IN THE DEPARTMENT OF PUBLIC SAFETY.**

**WHEREAS**, the Township of North Fayette (hereinafter "Township"), is a Municipal Corporation, duly organized and existing under the laws of the Commonwealth of Pennsylvania; and

**WHEREAS**, in July of 2024 a vacancy for the part-time, non-exempt position of Inspector, Fire Prevention, existed within the Department of Public Safety; and

**WHEREAS**, the Department of Administration has solicited applications for the position from interested candidates; and

**WHEREAS**, the Department of Public Safety has evaluated the applications and interviewed selected candidates; and

**WHEREAS**, the Department of Administration has completed pre-employment screening of selected candidates; and

**WHEREAS**, based on the recommendation of the Coordinator, Fire Prevention, and the Director, Public Safety, the Board of Supervisors wishes to appoint Brandon Spencer to the position.

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of the Township of North Fayette hereby resolves as follows, incorporating the above recitals by reference:

- SECTION 1.** Brandon Spencer is hereby appointed to the part-time, non-exempt position of Inspector, Fire Prevention, effective August 19, 2024, at a rate of \$14.00 per hour.
- SECTION 2.** Upon successfully being certified as an EMT/EMR by the Pennsylvania Department of Health, his compensation shall be increased to a rate of \$15.00 per hour.
- SECTION 3.** All prior resolutions are hereby repealed in whole or in part to the extent inconsistent herewith.
- SECTION 4.** This Resolution shall take effect immediately.

**AND NOW**, this 13<sup>th</sup> day of August 2024, upon motion duly made and seconded, the foregoing **RESOLUTION** is hereby adopted.
