ORDINANCE NO. 3511

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NUTLEY IN THE COUNTY OF ESSEX DISSOLVING THE NUTLEY VOLUNTEER EMERGENCY AND RESCUE SQUAD AND REPEALING PART I, ADMINISTRATIVE LEGISLATION, CHAPTER 60, FIRST AID SQUAD, OF THE TOWNSHIP CODE

WHEREAS, the Nutley Volunteer Emergency and Rescue Squad (“NVERS”) has proudly served the residents of the Township of Nutley (the “Township”) since 1953; and

WHEREAS, in or around 2020, NVERS became unable to continue rendering emergency medical services to the Township and its residents, which function was assumed by the Township Department of Public Safety; and

WHEREAS, NVERS has formally wound up its operations and business, and has transferred its assets to the Township; and

WHEREAS, by vote of its Board of Trustees, NVERS dissolved itself as a business entity on December 31, 2022; and

WHEREAS, pursuant to Section 60-8 of the Township Code, NVERS may be dissolved at any time by the Board of Commissioners by adopting an ordinance to that effect.

NOW, THEREFORE, BE IT ORDAINED, by the Board of Commissioners of the Township of Nutley, County of Essex, State of New Jersey, being the governing body thereof, as follows, that:

SECTION 1. The Nutley Volunteer Emergency and Rescue Squad be and hereby is dissolved.

SECTION 2. Part I, Administrative Legislation, Chapter 60, First Aid Squad, of the Township Code be and hereby is repealed.

SECTION 3. All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed to the extent of such conflict or inconsistency.

SECTION 4. Should any section, paragraph, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

SECTION 5. This Ordinance shall take effect upon its final passage and publication in accordance with applicable law.
