## BOROUGH OF OAKMONT ORDINANCE NO. O2 of 2023

AN ORDINANCE OF THE BOROUGH OF OAKMONT, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AMENDING AND UPDATING THE BOROUGH CODE OF ORDINANCES, CHAPTER 195, VEHICLES AND TRAFFIC, BY ADDING APPROVED EXISTING STOP SIGN LOCATIONS

WHEREAS, the Oakmont Police Department has the duty and authority to enforce the provisions of Chapter 195 of the Borough's Code of Ordinances, Vehicles and Traffic; and

WHEREAS, the Oakmont Borough Chief of Police has reviewed Chapter 195 and recommended changes to the same;

WHEREAS, the recommended changes will update and amend the Vehicle and Traffic regulations to accurately reflect the conditions of the Borough; and

WHEREAS, Borough Council has agreed with and adopted these recommendations;

NOW THEREFORE, IT IS ORDAINED and ENACTED by the Council of the Borough of Oakmont, Allegheny County, that Chapter 1950f the Oakmont Borough Code of Ordinances be amended as follows:

I. Article IV shall be amended by updating §195-15(B) to include the following to the list of approved stop signs:

Location	Direction of Travel
Village Drive	West
Pinehurst Lane	West
Merion Lane	West
St. Andrews Drive	West
St. Andrews Drive	West
Oak Street	West

II. Repealer. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

III Severability. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Borough that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section or part thereof not been included herein.
