

**ORDINANCE #06-24**

**ORDINANCE OF THE BOROUGH OF OAKLYN, COUNTY OF CAMDEN AND STATE OF NEW JERSEY AMENDING CHAPTER 120, VEHICLES AND TRAFFIC, IN THE CODE OF THE BOROUGH OF OAKLYN**

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Oaklyn, County of Camden, and State of New Jersey, that Article XIV., Schedules, in Chapter 120, Vehicles and Traffic, in the Code of the Borough of Oaklyn is hereby amended as follows:

**Article II.  
Parking**

**ARTICLE I.            ARTICLE II            SECTION 120-4.1    Exceptions to prohibition of  
Overnight parking.**

The following shall constitute exceptions to the prohibitions set forth in Schedule II against parking between the hours of 2:00 a.m. and 6:00 a.m. on any street in the Borough; provided, however, that no motor vehicle shall be permitted to be parked on any street for more than 24 continuous hours;

- A.    Retain in its entirety.
- B.    Retain in its entirety.
- C.    Such insignia shall be displayed at all times upon the driver side of the rear bumper of Motor vehicle being parked, as permitted herein, so that the same shall be visible.
- D.    Retain in its entirety.

- E. Retain in its entirety.

- H. Retain in its entirety.
- I. Retain in its entirety.
- J. Retain in its entirety.
- K. The Chief of Police may revoke any previously issued permit(s) if it is determined That the application contains false information; or if any changes were made to the drivers' or vehicles address; or any legal off street parking space or garage is added to the applicant's property.
- L. A person requesting a temporary exception to Ordinance 120-4 may submit daily Requests through the Oaklyn Police Department, however, shall not exceed 7 requests in any calendar month.


## **ARTICLE II.**

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.


## **ARTICLE III.**
