

**ORDINANCE AMENDING ORDINANCE NO. 114-39**

**Closing Hours**

**IN THE VILLAGE OF OAKWOOD, ILLINOIS.**

**ORDINANCE NO. 2023-05-15-01**

BE IT ORDAINED by the President and Board of Trustees of the Village of Oakwood, Vermilion County, Illinois, by and through Illinois Municipal Code and Section 1-7 of the Village Code, as follows:

114-39. Closing Hours shall be amended as follows:

The opening hours of establishments licensed under this Part 1 to serve and/or sell alcohol, permit patrons on the premises, conduct any business, or hold any congregation of people shall be permitted to conduct operations, as defined by the National Institute of Science and Technology during the following begin days and times, and end days and times, collectively the interim period hereafter defined as (Operating Hours):

Sunday at 7:00am	Sunday at 11:59:59pm

Wednesday at 7:00am	Wednesday at 11:59:59pm
Thursday at 7:00am	Friday at 12:59:59am
Friday at 7:00am	Saturday at 12:59:59am
Saturday at 7:00am	Sunday at 12:59:59am

It shall be illegal for establishments to serve and/or sell any alcoholic beverage outside permitted Operating Hours. No person is allowed to consume alcohol, nor remain on a licensed premises more than thirty (30) minutes after the end of Operating Hours.

**Repealer.** All ordinances, orders and resolutions or parts thereof, inconsistent herewith, are hereby repealed to the extent only of such inconsistency. This repealer shall not be construed as reviving any bylaw, order, resolution or ordinance or part thereof.

**Severability Clause.** In the event any provision of this Amendment is found to be invalid or unenforceable, only that particular provision or part so found, and not the entire Agreement, will be inoperative.

**EFFECTIVE DATE.** The clerk is directed by the corporate authorities to publish this Ordinance in pamphlet form. This Ordinance shall be in full force and effect after its passage and publication in accordance with 65 ILCS 5/1-2-4.



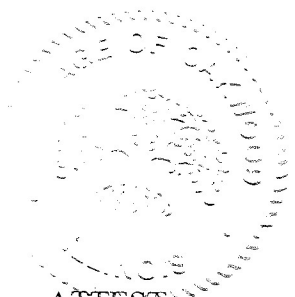
