AN ORDINANCE AMENDING CHAPTER 265 OF "THE MUNICPAL CODE OF THE VILLAGE OF OAKWOOD, ILLINOIS" REGARDING STOP INTERSECTIONS

WHEREAS, the Village of Oakwood ("Village") has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs; and

WHEREAS, the Village previously adopted Chapter 265 of its Code of Ordinances providing for Stop Intersections; and

WHEREAS, the Village has reviewed traffic at the intersections of Timberridge Dr. E and Kelly Dr. and Maple Ct. and Hickory Ct. and has determined that stop intersections provided for under this Ordinance shall enhance public safety; and

WHEREAS, the Village Board of Trustees of the Village President have determined that it is advisable, necessary and in the best interest of the Village and its residents to amend Chapter 265, Stop Intersections.

NOW THEREFORE, BE IT ORDAINED by the President and the Village Board of Trustees of the Village of Fisher, Illinois as follows:

Section 1. Incorporation Clause.

The President and Board of Trustees of the Village hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and does hereby, by reference, incorporate and make them part of this Ordinance.

Section 2. <u>Purpose</u>.

This Ordinance is to amend, Chapter 265, of the Village of Oakwood Code of Ordinances to include additional stop intersections.

Section 3. CODE OF OAKWOOD CHAPTER 265 AMENDMENT.

Chapter 265: Stop Intersections is hereby amended to now additionally include the following:

"There shall be stop signs erected confirming that traffic traveling east and west on Timberridge Dr. E shall stop at the intersections with Hickory Court, Kelly Drive and Maple Court and that traffic traveling north on Hickory Court, Kelly Drive, and Maple Court shall stop where it intersects with Timberridge Dr. E."

All other provisions of said Chapter 265: Stop Intersections shall remain in full force and effect.

Section 4. Superseder and Publication.

All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith, are to the extent of such conflict hereby superseded. A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

Section 5. Effective Date.

This Ordinance shall be in full force and effect upon passage and approval, as provided by the Illinois Municipal Code, as amended.

This ordinance is hereby passed, the "ayes" and "nays" being called, by the concurrence of a majority of the members of the Corporate Authorities then holding office at a regular meeting on the date set forth below.
