

IN THE CITY COUNCIL OF THE CITY OF OAKDALE STATE OF CALIFORNIA ORDINANCE 1286

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF OAKDALE AMENDING ARTICLE I OF CHAPTER 18 OF THE OAKDALE CITY CODE RELATING TO THE REGULATION OF MOTOR VEHICLES AND TRAFFIC.

The CITY COUNCIL OF THE CITY OF OAKDALE, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

SECTION 1. ADDING OF CODE: Article I of Chapter 18 of the Oakdale City Code is hereby added to read as follows:

Article I. Motor Vehicles and Traffic Regulations.

Sec. 18-8.1 Temporary parking signs.

Whenever the Chief of Police or Public Services Director determines that restricting parking in designated areas would serve a public interest from the holding of public or private gatherings or functions, street cleaning, road maintenance, special events, emergencies, or for other reasons, the Chief of Police or Public Services Director shall have the power and authority to order temporary signs to be prominently displayed indicating that the operation, parking or standing of vehicles is prohibited on such streets, alleys and parking lots. The temporary signs shall include clear, visible information regarding the purpose, duration, and enforcement hours of the parking restriction. Such signs shall be prominently displayed at least 24 hours in advance of the intended enforcement period and remain in place only during the existence of the event, and the Chief of Police or Public Services Director shall cause such signs to be removed promptly thereafter.

- (a) When signs authorized by the provisions of this section are in place giving notice thereof, no person shall operate, park, or stand any vehicle contrary to the direction and provisions of such signs.
- (b) When signs authorized by this provision of this section are in place giving notice thereof, any regularly employed and salaried officer of the police department of the City or a regularly employed and salaried Parking enforcement Officer may remove any vehicle that has been parked or left standing in violation of this article, pursuant to California Vehicle Code 22651(n).
- (c) The provisions of this ordinance shall not apply to emergency vehicles, law enforcement vehicles, or authorized special event vehicles.

SECTION 2. This Ordinance shall become effective thirty (30) days from and after its final passage and adoption, provided it is published in a newspaper of general circulation at least fifteen (15) days prior to its effective date.
