

RESOLUTION NO. 07 25 2024D

A RESOLUTION AUTHORIZING AN 18-MONTH RENTAL OF A SOLAR-POWERED SECURITY CAMERA FROM SENSERA SYSTEMS AND THE PURCHASE OF A POLE FOR THE MOUNTING OF THE CAMERA FROM S.S. RADIATOR & WELDING IN AN AMOUNT NOT TO EXCEED \$9,682.00.

WHEREAS, the City of O'Fallon is planning for the construction of the Center for Advanced Skills Training in Law Enforcement; and

WHEREAS, construction site video surveillance is required to protect equipment and also to provide the public with an ongoing view into the progress of the project; and

WHEREAS, City staff recommends approval of this Resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF O'FALLON, MISSOURI, AS FOLLOWS:

SECTION 1: The City Council approves on behalf of the City an agreement with Sensera Systems for an 18-month rental of a solar-powered camera at a cost not to exceed \$9,162.00, an agreement with S.S. Radiator & Welding for the purchase of a pole to be used for the mounting of the camera at a cost not to exceed \$420.00, and the purchase of miscellaneous supplies to complete the installation from a local hardware store at a cost not to exceed \$100.00 for a total cost of \$9,682.00, in substantial conformity with the terms shown on Exhibit A and Exhibit B attached hereto and incorporated herein by this reference as if set out here in full, together with such changes therein as shall be approved by the officers of the City executing same which are consistent with the provisions and intent of this legislation and necessary, desirable, convenient or proper in order to carry out the matters herein authorized. The City Administrator and other appropriate City officials are hereby authorized to execute any additional documents and take any and all actions necessary, desirable, convenient or prudent in order to carry out the intent of this legislation.
