A RESOLUTION AUTHORIZING AN AGREEMENT WITH JARRELL MECHANICAL CONTRACTORS PROVIDING FOR THE REPAIR OF THE DECTRON UNIT AT THE RENAUD CENTER, IN AN AMOUNT NOT TO EXCEED \$29,083.00.

**WHEREAS**, the City of O'Fallon has an HVAC system that is specifically designed for use in the Renaud Center's natatorium and the Dectron unit is a key component of that system; and

WHEREAS, the unit is in need of repair before the upcoming cold weather; and

WHEREAS, Jarrel Mechanical Contractors have been awarded a bid for repair of the City's HVAC units; and

WHEREAS, City staff recommends approval of this Resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF O'FALLON, MISSOURI, AS FOLLOWS:

**SECTION 1:** The City Council approves on behalf of the City an agreement with Jarrell Mechanical Contractors for the repair of the Dectron unit at the Renaud Center at a cost not to exceed \$29,083.00, in substantial conformity with the terms shown on Exhibit A attached hereto and incorporated herein by this reference as if set out here in full, together with such changes therein as shall be approved by the officers of the City executing same which are consistent with the provisions and intent of this legislation and necessary, desirable, convenient or proper in order to carry out the matters herein authorized. The City Administrator and other appropriate City officials are hereby authorized to execute the Agreement and such additional documents and take any and all actions necessary, desirable, convenient or prudent in order to carry out the intent of this legislation.

On our preventative maintenance visit, it was found that (3) Condenser Fan Motors, (1) Exhaust Blower Motor, (1) Inducer Motor, and (1) Humidity/Temperature Sensor have failed in Dectron-1. We recommend replacing this equipment to return this unit to normal operation. We propose to provide labor and materials to replace (3) Condenser Fan Motors, (1) Exhaust Blower Motor, (1) Inducer Motor, and (1) Humidity/Temperature Sensor.

#### Our proposal includes:
