BOROUGH OF OGDENSBURG COUNTY OF SUSSEX ORDINANCE 03-2024

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTERS 2 AND 6 OF THE CODE OF THE BOROUGH OF OGDENSBURG ENTITLED "ADMINISTRATION" AND PARKS AND RECREATION AREAS" RESPECTIVELY

WHEREAS, the Borough of Ogdensburg desires to amend Chapters 2 and 6 of the Code of the Borough of Ogdensburg ("Code") entitled "Administration" and "Parks and Recreation Areas" respectively regarding possession of fishing and swimming badges and/or boat decals in Recreation and Swimming Areas, and enforcement and penalties for violations.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Borough of Ogdensburg, in the County of Sussex, and State of New Jersey that Chapters 2 and 6 of the Code entitled "Administration" and "Parks and Recreation Areas" respectively are hereby amended as follows:

SECTION I. Section 2-63.5 entitled "Licenses, Permits, Records and Certificates" shall be amended to replace the description for "Heater's Pond Badge" under "Parks and Recreation Areas" and "OGDENSBURG RESIDENTS" as follows:

Chapter 2. Administration

Article VII. Administrative Fees

§ 2-63.5 Licenses, Permits, Records and Certificates.

Parks and Recreation Areas

OGDENSBURG RESIDENTS

Heater's Pond Badge for swimming and fishing

All other descriptions contained in Section 2-63.5 shall remain unchanged.

SECTION II. Section 6-1.7 entitled "Regulations for Swimming Area" is amended to add new Section 6.1.7 (m) as follows:

Chapter 6. Parks and Recreation Areas

§ 6-1.7 Regulations for Swimming Areas.

m. A current and valid badge issued by the Borough is required during the summer season and shall be worn and visible while engaging in any swimming activity in the Swimming Area as defined in Section 6-1.1. Badges shall be presented upon request by any Borough officer, official, employee, or lifeguard. Annual badges shall be obtained at the Borough Municipal Building. Badges are non-transferrable.

SECTION III. Section 6-1.8(a) under "Regulations Governing Fishing, Boating, Hunting, or Trapping" is replaced as follows:

§ 6-1.8 Regulations Governing Fishing, Boating, Hunting, or Trapping.

a. The privileges of fishing and/or boating shall be enjoyed only by the following persons:

SECTION IV. Section 6-1.8 entitled "Regulations Governing Fishing, Boating, Hunting, or Trapping." is amended to add new Section 6-1.8(a)(5) as follows:

§ 6-1.8 Regulations Governing Fishing, Boating, Hunting, or Trapping.

- a. [Revised as set forth in Section III above]
 - 5. A current and valid badge issued by the Borough is required for fishing and shall be worn and visible while fishing in any Recreation Area. Fishing badges shall be presented upon request by any Borough officer, official, or employee. Annual badges shall be obtained at the Borough Municipal Building. Badges are nontransferrable.

SECTION V. Section 6-1.8(b)(2) under "Regulations Governing Fishing, Boating, Hunting, or Trapping." is replaced as follows:

§ 6-1.8 Regulations Governing Fishing, Boating, Hunting, or Trapping.

- b. [No Change]
 - 2. Those residents to whom the Borough has issued a permit (decal), which must be displayed on the left side of bow prior to launching. Any person engaging in boating and fishing shall have a boat decal and badge as provided for in this Section.

SECTION VI. Section 6-1.11(r)(1) under "General Provisions" is replaced as follows:

§ 6-1.11 General Provisions.

- r. [No Change]
 - 1. The Police Department shall enforce all rules and regulations of this Chapter and the State Laws regarding same. The Police Department shall have the authority to eject from any Borough Park, Field, Recreation Area, and Swimming Area, any person acting in violation of this Chapter.

SECTION VII. If any article, section, subsection, sentence, clause, or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

SECTION VIII. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION IX. This Ordinance shall take effect immediately upon final passage and publication according to law.
