TOWNSHIP OF OLD BRIDGE ORDINANCE 2023-22

AN ORDINANCE IMPLEMENTING THE PROVISIONS OF
TITLE 39 NEW JERSEY MOTOR VEHICLE STATUTES SUBTITLE ONE
WITH VARIOUS TRAFFIC REGULATIONS APPLICABLE
TO THE OAKS I DEVELOPMENT, SCHULMEISTER ROAD AND ASTER CIRCLE, REGULATING THE
USE OF SAID ROADWAYS

BE IT ORDAINED By the Township Council of the Township of Old Bridge, County of Middlesex, State of New Jersey as follows:

SECTION 1: PURPOSE

The purpose of this Ordinance is to grant permission to the Old Bridge Township Police Department to effectively make the provisions of Subtitle One Chapter 5A of Title 39 (the "Act) with various traffic regulations applicable to the property commonly known as OAKS I DEVELOPMENT which allows the regulation of said roadways by motor vehicles.

The representative of the Oaks 1 Development has filed a written request with the Township of Old Bridge Municipal Clerk on or about November 6, 2023, pursuant to N.J.S.A. 39:5A-1. The letter requesting enforcement specifically includes Schulmeister Road and Aster Circle.

This written request, in pursuance of section 1 of the Act shall not be deemed to constitute a dedication to public use, of any such roads, streets, driveways, trails, terraces, bridle paths, parkways, parking areas, or other roadways open to or used by vehicular traffic, nor shall it be construed to prevent such persons, corporations or institutions, as owners of such property open to or used by the public for purposes of vehicular travel by permission of such persons, corporations or institutions and not as a matter of public right, from prohibiting such use or from requiring other or different or additional conditions than those specified in subtitle 1, Title 39, of the Revised Statutes, or otherwise regulating such use as may seem best to such persons, corporations or institutions.

SECTION 2: INCONSISTENT ORDINANCES

All ordinances or parts of ordinances inconsistent with or in conflict with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3: PARTIAL INVALIDITY

If any section, paragraph, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, clause or provision so adjudged and the remainder shall be deemed valid and effective.

SECTION 4: EFFECTIVE DATE

- A. Except as set forth at subparagraphs B and C hereof, this Ordinance shall take effect on the earlier of the following dates: (1) on the date the Mayor affixes his/her signature thereto and returns same to the Municipal Council by delivering it to the Municipal Clerk pursuant to N.J.S.A. 40A:69A-41 or (2) on the tenth day following presentment to the Mayor of the Ordinance pursuant to N.J.S.A. 40:69A-41 applicable when the Mayor has failed to return the Ordinance; whichever occurs first.
- B. If the Mayor vetoes the Ordinance (in the manner set forth at N.J.S.A. 40:69A-41), this Ordinance 2023-22 shall become effective upon the Township Council's vote to override the Mayor's veto.
- C. Notwithstanding any other provision hereof, this Ordinance shall not take effect less than twenty (20) days after its final passage by the Council and approval by the Mayor, where such approval is required, unless the Council shall have also adopted a resolution declaring an emergency and at least two thirds (2/3) of all the members of the council vote in favor of such resolution.
