



**BOROUGH OF ORADELL
ORDINANCE #22-4**

**AN ORDINANCE AMENDING CHAPTER 280
OF THE CODE OF THE BOROUGH OF ORADELL
ENTITLED VEHICLES AND TRAFFIC**

WHEREAS, the Borough of Oradell has determined it to be in the best interests of the safety, health and welfare of the residents of the Borough of Oradell to provide for handicapped parking spaces on Borough streets; and

WHEREAS, the Oradell Police Department has surveyed the locations where handicapped parking spaces have been requested and have recommended that certain parking spaces be designated for use by handicapped individuals; and

NOW THEREFORE BE IT ORDAINED, by the Governing Body of the Borough of Oradell as follows:

1. Chapter 280, Section 46, Schedule XX dealing with handicapped parking on roadways, is hereby amended as follows:
 - A. Two new handicapped parking spaces shall be designated at the following locations:

Center Street
From the North West Corner of Kinderkamack Road and Center Street extending 175 feet West on Center Street and then continuing another 22 feet West.

Center Street
From the North West Corner of Kinderkamack Road and Center Street extending 197 feet West on Center Street and then continuing another 22 feet West.
2. All unauthorized signs regulating traffic and/or parking shall be identified and removed within 30 days of the passage and publication of this ordinance and no unauthorized signed shall be erected without a supporting ordinance duly passed and published as provided by law.
3. This Ordinance shall become effective immediately upon passage and publication as provided by law.
