AN ORDINANCE TO AMEND CHAPTER 115 TITLED, "FEES" OF THE CODE OF THE BOROUGH OF ORADELL

WHEREAS, the Mayor and Council of the Borough of Oradell believe that it is in the best interests of the residents of the Borough of Oradell to amend and provide for various fees for Borough services;

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Oradell as follows:

- I. Chapter 115-9 titled, "Police Department" shall be amended as follows:
- § 115-9. Police Department.
- A. The fees for police investigation reports shall be:
- B. The fees for a motor vehicle accident report shall be as determined by a third party vendor.
- C. The fees for photographs shall be \$10 per photo.
- D. The fees for parking permits shall be as follows:
- (1) Resident permit: none.
- (2) Nonresident employee permit: \$75 per calendar year. Prorated after July 1 to \$37.50.
- (3) Overnight parking permit: none.
- (4) Borough employee permit: none.
- (5) Nonresident student parking permit: \$75 September 1 through August 30.
- E. The fee for an audio recording of radio and/or telephone police communications shall be the rate of pay per hour of the assigned Lieutenant as established by contractual salary and as amended by salary.
- F. The fees for fingerprinting for all noncriminal fingerprint cards for submission to Federal Bureau of Investigation (i.e., employment application checks, license application, firearms Identifications, carry permits, permits to purchase, etc.) shall be pursuant to N.J.A.C. 13:59-1.1 et seq.
- G. Special duty assignments such as private security and traffic safety for utility maintenance shall be billed at a rate of \$148 per hour per officer, inclusive of administrative fees.
- H. The fee for a peddling or soliciting permit shall be \$100.

- I. The fee for a canvassing/handbill permit shall be \$10.
- J. The fees for security alarm systems shall be as follows:
- (1) An annual registration fee of \$25 payable at the time of initial application and at the inception of each subsequent service year.
- (2) The fees set forth in § 115-9K(1) above shall not be refundable in whole or in part for any reason.
- K. The fee for Body Worn Camera and Mobile Video Recordings shall be the rate of pay per hour of the assigned Lieutenant as established by contractual salary and as amended by salary ordinance.
 - VI. All other ordinances inconsistent herewith are hereby repealed.
 - VII. This Ordinance shall take effect after final passage and publication as required by law.
