Pursuant to warrant duly served and posted, the inhabitants of the Town of Orange qualified to vote in elections and town affairs at the Special Town Meeting held at the Ruth B. Smith Auditorium on April 3, 2017 at 7:00 p.m. passed the following article:

**ARTICLE 19: ZONING DISTRICT B RE-ZONING PROPOSAL**

Motion passed, by the required 2/3, that the Town vote to amend Chapter 205, Section II, Subsection 2110 of the Town of Orange Zoning Bylaw, by amending the "Official Zoning Map, Orange, Massachusetts" dated June 6, 2014 which said Map is on file with the Town Clerk by adopting the new district boundary lines shown on the map entitled "Route 2 Work, A Job Creation Corridor Zone Change, Town of Orange, November 2016" to further (1) include all of the following parcels in the Residential/Commercial District (B): 129-13; 130-5; 130-6; 130-7; 130-8; 130-9; 130-10; 250-6; 250-12; 250-18; 250-19; 250-23; 250-24; 250-26; 253-42 and 253-43; and (2) remove the language describing the boundaries of the B District; and (3) change the date of the "Official Zoning Map, Orange, Massachusetts" referenced therein to April 3, 2017.

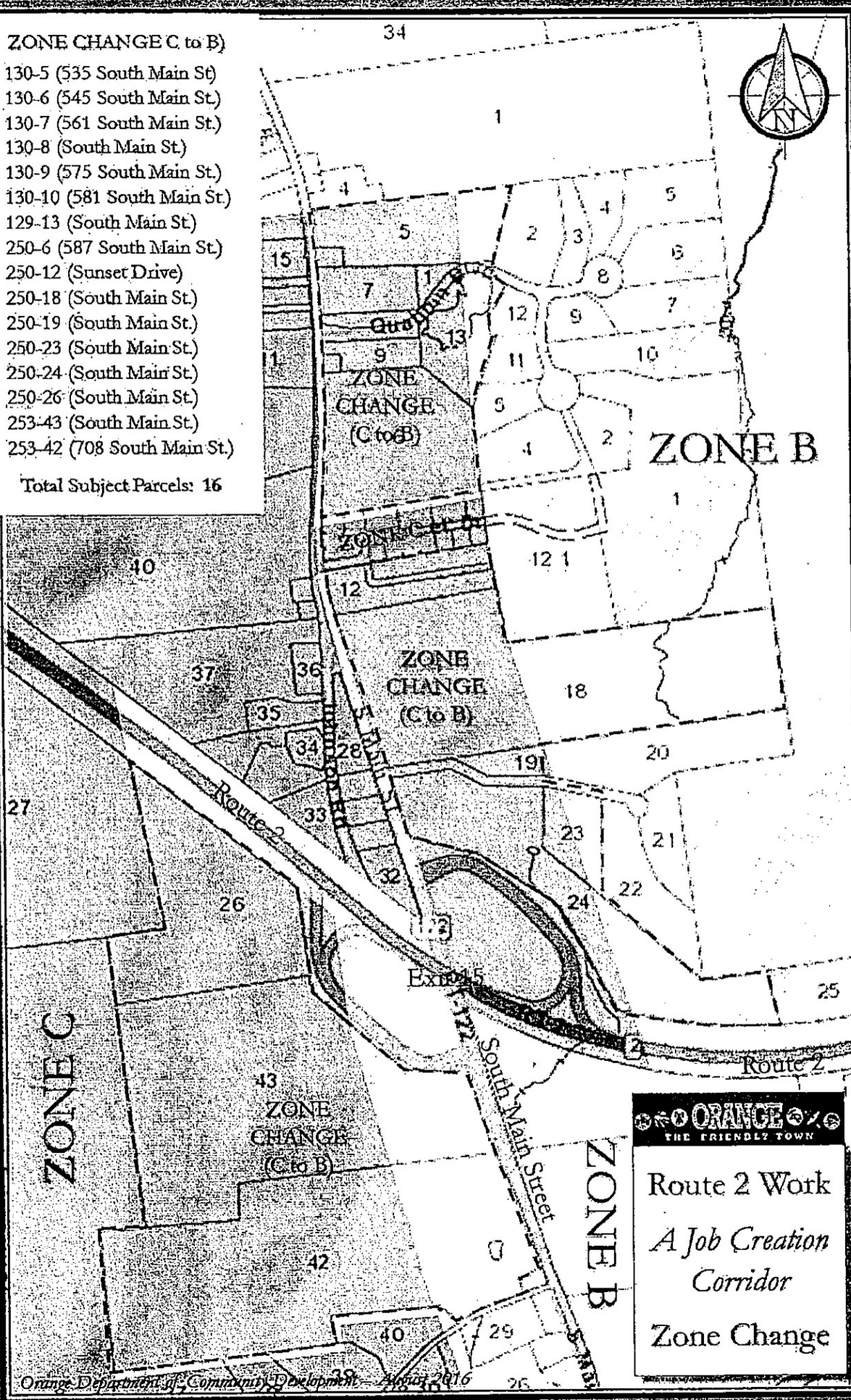
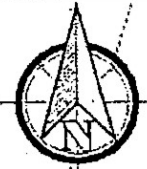
