A LOCAL LAW OF THE VILLAGE OF PATCHOGUE

The Amended Section 415-6 of the Village Code which shall read as follows:

§ 415-6 Stop intersections.

The following intersections are hereby designated as stop intersections, and all vehicles approaching the first-named street from the following listed streets shall come to a full stop before entering the first-named street unless otherwise directed by a police officer or signal:


