CALL TO ORDER

Supervisor Barton called the meeting to order at 6:30 p.m. and led those present in the Pledge of Allegiance to the Flag, followed by a moment of silence. Emergency exit procedures were noted.

REGULAR MEETING MINUTES - JULY 20, 2021

RESOLUTION No. 215-2021 Motion by Councilperson Judd, seconded by Councilperson Roose, to accept the Minutes of the regular meeting held on July 20, 2021, as presented. Motion carried: Aye 3 (Barton, Roose, Judd) Nay 0

TOWN CLERK REPORT

The Town Clerk and VFW Reports for July have been submitted to the Supervisors Office. School tax bills are in the production stages and will go out at the end of August. There is a meeting Thursday with General Code for MapLink so we can start moving forward with the project.

HIGHWAY DEPARTMENT REPORT

Supt. Christ reported they had an Insurance and Safety inspection at the Highway Garage and were awarded two plaques for having zero workman's comp cases in 2019 and 2020. They completed

three more Town roads and have been very busy working every day for the last five weeks on County projects. It looks like the Department will bring in over \$150,000.00 in revenue this year.

BUILDING DEPARTMENT REPORT

Mark Lenzi reported the Department is receiving a lot of calls about creating water districts around Moul and Curtis Roads. The DEC is involved with 442 Trimmer Road and will be making a visit to the property. The Zoning Board of Appeals is still in need of two more members. The Town Clerk said the position was advertised in Westside News, the Town website and on the Recreation Facebook page.

PARKS AND RECREATION REPORT

Tom Venniro reported summer programming is wrapping up and has gone very well. This summer featured Food Truck Wednesday's, the all-new Concert Series, Summer Camp, Nature Camp and numerous sports and enrichment camps. They are in the planning stages for fall programming and hope to release those by the end of August.

Summer Send-Off will be held on August 27, 2021. The evening will highlight outdoor fun including food from Barton's Parkside Hots, J&S Fried Dough, and Lugias Ice Cream Food Truck. There will be a concert in the park, bounce houses, giveaways, an outdoor movie showing Toy Story 4, and fireworks prior to the start of the movie. Mr. Venniro thanked Wegmans for sponsoring the fireworks. The event is free for all except for food purchases. There will be a Town Board tent set up to answer questions and promote vacant board seats.

The Town received the necessary playground parts last week and can continue moving forward with that project. The plan is to officially open the playground at the event on August 27, 2021, with more details to follow.

Head Grounds Equipment Operator – Applications for the position are due by August 27, 2021. The hope is to recommend a candidate to be hired and rate approval at the first meeting in September.

Capital Projects – The Department is in the process of making repairs to the drop box area. Other projects in progress are the Town Landscaping (South end of the building), Town Hall Thermostats, Town Board Room Work, Meeting House Rehabilitation.

LIBRARY REPORT

Amy Hogue, Library Director, reported that the amount of people visiting the library is similar to pre-pandemic days with over 3,000 people in the month of July. The summer reading program is wrapping up and they are working on their fall programs.

MISCELLANEOUS REPORTS

TOWN BOARD APPOINTMENT - TINA BROWN

RESOLUTION NO. 216-2021 Motion by Councilperson Roose, seconded by Councilperson Judd, to appointment Tina Brown to the Town Board effective immediately ending December 31, 2021.

Motion carried: Aye 3 (Barton, Roose, Judd) Nay 0

Supervisor Barton noted that the Town Clerk, Councilperson Roose and the Supervisor all attended a Press Conference this afternoon at the Town of Greece regarding an event being held tomorrow night at Braddock's Bay Park called Stop the Violence. These events have been held throughout Monroe County. The event at Braddock's Bay Park starts at 6:15pm.

PUBLIC FORUM

Supervisor Barton asked if there were any citizens who would like to address the Town Board with any concerns.

Tanya Calabria, 578 Burritt Road, stated her and many of her neighbors have concerns for the safety of the families living on Burritt Road. There are speeding vehicles and up and down the road and burnouts in the middle of the road; it has changed their neighborhood. Her mom does not feel safe being in her own yard, and they have lived there over 30 years. Videos and photos have been submitted to the Town. Families are afraid of their kids and pets being in the front yard for fear a car will go out of control into the yard, a vehicle has caught on fire.

Tim Coles, 571 Burritt Road, said he moved in a year ago and did not sign up for what is happening on the road. Cars are speeding and crossing the center line in traffic; the road has been destroyed and his dog was hit by a vehicle. It is not safe or fair to the taxpayers to have to deal with this.

Sandy Reike, 585 Burritt Road, said the road has been destroyed and the road was just repaired, and wondered who pays to fix that, the taxpayers. There is noise, smoke, burnouts, and a vehicle started on fire; she is over it. The neighbors are being intimidated and fear retaliation. Mario Reike, said this occurs all hours of the day and night.

Residents are being yelled at in their own yards, the cops have been called many times and Sheriff Baxter has been made aware of the issue. Supt. Christ stated he has been aware of it for two years, he reached out to the father of one individual hoping that it would stop it, but it has not. He brought it to the attention of Monroe County and sent pictures because they are defacing a County Road and his understanding is it was brought to the attention of the individual's father again. The road is not even a year old and it is destroyed, yellow line and white line are gone.

Tom Sisson, 12 Hill Road, says he heard fully automatic gun fire occurring at the property on several occasions.

Cindy Sanger, 566 Burritt Road, says she is concerned about everyone's safety on the road and fears someone is going to get hurt. She is afraid to pull out of her driveway because of the speed being used on the road.

Unidentified member of the audience asked if it was possible to get speedbumps on the road, or an increased police presence. Supervisor Barton said because it is a county road there is not much the Town can do about that. An unidentified member of the public said how would the Town plow if there were speedbumps. Supt. Christ said it can be done, but you must be cautious.

Supervisor Barton said he will contact and relay the resident and Town concerns to the Monroe County Sheriff's Office and try to set up a meeting with Sheriff Baxter. He will also reach out to the County DOT to see what options are available to the Town.

Mike Weldon, 245 Dunbar Road, asked where they can bring brush. Supt. Christ said that County Work and Town Road must get done and he does not have the resources to have a crew on brush pick-up year-round. Currently there is no place for residents to bring their brush, that could change if the Town and Village purchase land jointly, which is being discussed.

Mr. Weldon asked if there was any way to get a repair made at the corner of 259 and Parma Center. It was noted that several calls have been made by the Town to the State DOT about the intersection and the State says they do not have any plans to fix this soon. It was suggested that resident's start calling the State DOT with their concerns.

PUBLIC HEARING

The Public Hearing was opened at 7:07 pm. Supervisor Barton read the following legal notice that was advertised in the Westside News and on the Town Website and Bulletin Board.

PUBLIC HEARING - LAKESHORE SANITARY SEWER BOND

PLEASE TAKE NOTICE, That the Town Board of the Town of Parma will hold and conduct a Public Hearing to discuss the Lakeshore Sanitary Sewer Bond, which Public Hearing will be held at the Parma Town Hall, 1300 Hilton Parma Corners Road, Hilton, New York on the 17th day of August 2021, at 7:00 PM and at which Public Hearing all interested persons shall be heard concerning the subject matter thereof.

Supervisor Barton gave some background information on the project and noted the Bonded amount will be for the resident's portion owed for the Lakeshore Sewer District, which is 5% of the total project. The state is paying 95% of the project through a redi-grant. The overall project is

\$5.6 million and the amount to be bonded is \$280,000. The bond will be paid over 30 years through the tax bill.

Supervisor Barton asked if there was anyone in the audience that would like to speak. There was no response, and the Public Hearing was closed at 7:10pm.

A RESOLUTION AUTHORIZING THE ISSUANCE OF \$280,000. BONDS OF THE TOWN OF PARMA, MONROE COUNTY, NEW YORK TO PAY THE COST OF THE ESTABLISHMENT OF THE LAKESHORE SEWER DISTRICT IN SAID TOWN OF PARMA

RESOLUTION No. 217-2021 Motion by Councilperson Roose, seconded by Councilperson Barton.

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 12-A of the Town Law, and more particularly a final order, dated September 15, 2021, the Town Board of the Town of PARMA, Monroe County, New York, has established the Lakeshore Sewer District; and

WHEREAS, the maximum cost of said improvements is estimated to be \$5,600,000; and

WHEREAS, said capital project has been determined to be a Type I action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, the implementation of which as proposed the Town Board has determined will not result in any significant adverse environmental effects: and

WHEREAS, it is now desired to authorized the financing of said improvements;

NOW, THEREFORE BE IT RESOLVED by the affirmative vote of not less than two-thirds of the total voting strength of the Town Board of the Town of PARMA, Monroe County, New York, as follows.

<u>SECTION I</u>: For the specific object or purpose of paying the cost of improvements in connection with the establishment of the Lakeshore Sewer District, consisting of the installation as described in the engineer's report prepared in connection therewith, there are hereby authorized to be issued \$280,000 bonds of the Town of PARMA, Monroe County, New York, pursuant to the provisions of the Local Finance Law.

<u>SECTION II</u>: It is hereby determined that the maximum estimated cost of the aforesaid improvements is \$5,600,000 and that the plan for the financing thereof shall consist of the issuance of \$280,000 bonds of said Town hereby authorized to be issued therefore pursuant to the provisions of the Local Finance Law and receipt of the Redi-Grant from the State of New York in the sum of \$5,320,000.

SECTION III: It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is 30 years, pursuant to subdivision 1 of paragraph a of Section 11.00 of the Local Finance Law. It is further determined that the maximum maturity of the bonds herein authorized will exceed five years.

<u>SECTION IV</u>: The faith and credit of said Town of PARMA, Monroe County, New York are hereby irrevocably pledged to the payment of the principal of and interest on such bonds as the same respectively become due and payable. There shall be annually assessed upon all the taxable real property within said Sewer District in the

manner provided by law an amount sufficient to pay the principal and interest on said bonds as the same become due, but if not paid from such sources, all the taxable real property in said Town shall be subject to the levy of ad valorem taxes without limitation as to rate or amount sufficient to pay the principal of and interest on said bonds as the same shall become due.

SECTION V: Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

SECTION VI: The powers and duties of advertising such bonds for sale, conducting the sale and awarding the bonds, are hereby delegated to the Supervisor, who shall advertise such bonds for sale, conduct the sale, and award the bonds in such manner as she shall deem best for the interests of the Town, including, but not limited to the power to sell said bonds to the New York State Environmental Facilities Corporation, provided, however, that in the exercise of these delegated powers, he shall comply fully with the provisions of the Local Finance Law and any order or rule of the State Comptroller applicable to the sale of municipal bonds.

SECTION VII: All other matters, except as provided herein relating to such bonds, including determining whether to issue such bonds having substantially level or declining annual debt service and all matters related thereto, prescribing whether manual or facsimile signatures shall appear on said bonds, the date, denominations, maturities and interest payment dates, place or places of payment, and also including the consolidation with other issues, shall be determined by the Supervisor.

SECTION VII: The Supervisor is hereby further authorized, at his/her discretion, to execute a project financing and loan agreement, and any other agreements with the New York State Department of Health and/or the New York State Environmental Facilities Corporation, including amendments thereto, and including any instruments (or amendments thereto) in the effectuation thereof, in order to effect the financing or refinancing of the specific objection or purpose described in Section 1 hereof, or a potion thereof, by a bond, and, or note issue of said Town in the event of the sale of same to the New York State of Environmental Facilities Corporation.

<u>SECTION IX</u>: The intent of this resolution is to give the Supervisor sufficient authority to execute those applications, agreements, instruments or to do any similar acts necessary to effect the issuance of the aforesaid bonds and, or notes without resorting to further action of this Town Board.

SECTION X: The resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

SECTION XI: The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date or such publication, or

3) Such obligations are authorized in violation of the provisions of the Constitution.

<u>SECTION XII</u>: This resolution, which takes effect immediately, shall be published in full in the West Side News, the official newspaper, together with a notice of the Town Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

Motion carried: Aye 4 (Barton, Roose, Judd, Brown) Nay 0

Gary Hafner, 80 West Beach, asked if there was a timeline for the project yet. Supervisor Barton said they are waiting on permits from the DEC and are hoping to start at the end of October.

Councilperson Roose said he talked to residents who state they are not going to tie into the system and asked if that is possible. Supervisor Barton said resident's will not be required to tie in at this time, but they will still be required to pay the portion due through taxes for the district. By not tying in at this time the resident loses the benefit of the grant covering much of the costs; if they decide to tie in at a later time, they will be responsible for all associated costs.

BUSINESS ITEMS

JUSTICE COURT ASSISTANCE PROGRAM- DIVIDING DOOR

Supervisor Barton noted that the resolution passed at the last meeting needed very specific language for the grant.

Be it RESOLVED that The Board of the Town of Parma authorizes the Parma Town Court to apply for a JCAP grant in the 2021/22 grant cycle up to \$30,000.00.

ESTABLISH PETTY CASH ACCOUNT - SPECIAL POLICE

Supervisor Barton said the Administrative Committee has agreed to deposit \$200 each into a petty cash account for use by the Special Police for water and food during events.

RESOLUTION NO. 219-2021 Motion by Councilperson Judd, seconded by Councilperson Roose, to establish the Special Police Petty Cash Fund and deposit \$200.00 into the fund. Motion carried: Aye 4 (Barton, Roose, Judd, Brown) Nay 0

<u>UNAPPROPRIATED FUND BALANCE - HIGHWAY DEPT.</u>

Supt. Christ explained he purchased a truck and due to a miscommunication with the DMV, the lien holder, and the Town a payment has not been made yet. Van Bortel started charging \$5 per day so tonight a transfer is being approved so the payment can be made. Key Bank will reimburse the money to the Town as soon as the Title is returned by the DMV showing them as lienholder. This payment will be authorized when the prepaids are approved.

He would like to transfer \$50,000 out of the salt line in the budget to purchase a 2013 International 6-wheel dump truck with plow, wing, and salter for \$42,000 from the Village of Newark. The truck has 23,000 miles. This truck would replace the 1997 International 6-wheel dump truck with 148,600 miles that needs work. The Department needs three trucks to plow the subdivisions efficiently.

He would also like to purchase a 1.5 Ton Wacker Vibratory Roller in the amount of \$8,000 to use on the roads. This equipment would be very helpful with county work. This year we had to rent one out when we needed it, not a lot of Towns have them. The Town could get revenue when used for county projects to make the money back. Other Towns could also rent it from us.

Supervisor Barton asked if Supt. Christ is comfortable that the Department will be in good shape financially. Supt. Christ said he was and that he feels they are going to make more money on road work this year than he anticipated.

She spoke with the Assessor's Office and they said they are quiet right now but they will be busy when tax collection begins again. She noted that it is exciting to see people at the library again.
