ORDINANCE AMENDING CHAPTER 295 OF THE CODE OF THE CITY OF PASSAIC ENTITLED "VEHICLES AND TRAFFIC" ARTICLE XII, "SCHEDULES" SECTION 21, "SCHEDULE IIB: ALTERNATE PARKING"

TO ELIMINATE ALTERNATE SIDE PARKING FOR PORTIONS OF MERCER STREET, DWASLINE ROAD, AND ALLEN STREET

WHEREAS, pursuant to N.J.S.40:48-2, the governing body of a municipality may make, amend, repeal, and enforce such other ordinances, regulations, rules and by-laws not contrary to the laws of this state or of the United States, as it may deem necessary and proper for the good government, order and protection of person and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any law; and

WHEREAS, Chapter 295 of the Code of the City of Passaic, "Vehicles and Traffic," Article XII, Section 21, "Schedule IIB: Alternate Parking," provides the streets, or portions thereof, where no person shall park a vehicle between the hours specified upon any of the following streets or parts of streets in accordance with the provisions of §295-5B; and

WHEREAS, in the interests of good government, order and protection of person and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, the City of Passaic wishes to amend Section 21, "Schedule IIB: Alternate Parking," to eliminate alternate side parking for portions of Mercer Street, Dwasline Road, and Allen Street.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Passaic, that Chapter 295 of the Code of the City of Passaic, "Vehicles and Traffic," Article XII, "Schedules," Section 21, "Schedule IIB: Alternate Parking," is hereby amended as follows:

SECTION I

Chapter 295. Vehicles and Traffic
Article XII. Schedules
§ 295-21. Schedule IIB: Alternate Parking

Locations Designated shall be amended by the deletion of the following:

Mercer Street	North	8:30 to 10:30/Monday	Entire Length
Mercer Street	South	8:30 to 10:30/Thursday	Entire Length
Dwasline Road	North	8:30 to 10:30/Tuesday	Brook Avenue to Clifton City Line
Dwasline Road	South	8:30 to 10:30/Wednesday	Brook Avenue to Clifton City Line
Allen Street	East	8:30 to 10:30/Thursday	Entire Length
Allen Street	West	8:30 to 10:30/Monday	Entire Length

SECTION II

Chapter 295. Vehicles and Traffic
Article XII. Schedules
§ 295-21. Schedule IIB: Alternate Parking

Locations Designated shall be amended by the addition of the following:

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>HOURS (A.M.)/DAYS</u>	<u>LOCATION</u>
Mercer Street	North	8:30 to 10:30/Monday	Third Street to Dead End
Mercer Street	South	8:30 to 10:30/Thursday	Third Street to Dead End

SECTION III

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION IV

All ordinances or parts of ordinances to inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION V

This ordinance shall take effect upon publication as provided by law.


