ORDINANCE NO# 2457-24

**ORDINANCE AMENDING THE DESIGNATION OF RESTRICTED PARKING FOR DISABLED PERSONS BY NJ LICENSE PLATE NUMBER**

**WHERE AS** the total number of Handicapped Parking Spaces Restricted by New Jersey License Plate Number as per last ordinance was 404 Handicapped Parking Spaces.

**WHERE AS** the total number of Handicapped Parking Spaces Restricted by New Jersey License Plate Number as per this ordinance is 412 Handicapped Parking Spaces.

**BE IT ORDAINED** by the City Council of the City of Passaic and State of New Jersey that Chapter 295 ARTICLE XII Schedule XV shall be amended as follows:






