# ORDINANCE NO. 2470-24

ORDINANCE AMENDING CITY CODE OF THE CITY OF PASSAIC, CHAPTER 295, "VEHICLES AND TRAFFIC," ARTICLE XVI, "BUS STOPS," SECTION 38 "LOCATIONS" TO REMOVE BUS STOP ON PASSAIC STREET

WHEREAS, N.J.S.A. 40:48-2 provides in relevant part that a municipality may make and enforce such ordinances, rules and regulations not contrary to the laws of this state or of the United States as it may deem necessary and proper for the good government, order and protection of persons and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants; and

WHEREAS, the City Code of the City of Passaic, Chapter 295, "Vehicles and Traffic," Article XVI, "Bus Stops," Section 38, "Locations," designates certain areas within the City of Passaic as bus stops and provides that and no person shall park a vehicle at any time at such locations; and

WHEREAS, New Jersey Transit has requested that the City of Passaic remove one (1) bus stop on Passaic Street; and

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Passaic that the City Code of the City of Passaic, Chapter 295, "Vehicles and Traffic," Article XII, "Schedules," is hereby amended as follows:

# **SECTION I**

Chapter 295. Vehicles and Traffic

Article XVI. Bus Stops

§ 295-38. Bus Stops Locations Designated shall be amended by the deletion of the following:

SIDE

**LOCATION** 

Passaic Street

South

Fourth Street (far side), beginning at the easterly curbline of Fourth Street and extending 100 feet easterly therefrom

## **SECTION II**

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

## **SECTION III**

All ordinances or parts of ordinances to inconsistent herewith are hereby repealed to the extent of such inconsistency.

#### **SECTION IV**

This ordinance shall take effect upon publication as provided by law.
