AN ORDINANCE AMENDING CHAPTER 395 OF THE BOROUGH CODE OF THE BOROUGH OF PARAMUS TITLED "SWIMMING POOLS" BY REPEALING AND REPLACING §395-4, §395-5, §395-6, 397-7 AND §397-8.

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Paramus, County of Bergen, State of New Jersey as follows: Section 1. The Code of the Borough of Paramus at §395-4 titled "Membership; Guest", §394-5 titled "Fees", §395-6 titled "Identification Badges", and §396-7 titled "Hours of Operation" and §395-8 titled "Rules and Regulations", are hereby repealed and replaced by the following:

CHAPTER 395. SWIMMING POOLS ARTICLE I. Swimming Pool Facilities § 395-4 Membership; guests.

- <u>A.</u> Residence requirements. Membership is limited to permanent residents of the Borough of Paramus who have paid the required fees. Out-of-town memberships will be offered at the discretion of the Pool Commission.
- B. Types of memberships:
 - (1) Family membership shall include any of the following who reside in the same household: husband; wife; civil union partner; unmarried children; legal guardian children.
 - (2) Individual membership shall be available to any permanent resident of the Borough over 16 years of age.
 - (3) Senior citizen membership shall be available to permanent residents of the Borough 62 years of age or older.
- C. Memberships not transferable. All memberships issued for the use of the swimming pool facilities are not transferable.
- D. Guests. Each family membership shall be offered for purchase a number of guest passes listed in the current pool rules.
- E. Membership fee refund. Membership fees are not refundable.

- A. Residents of the Borough who are members of the Armed Forces of the United States on active duty and who are otherwise eligible to use the facilities shall be allowed to swim at no charge; provided, however, that they present evidence to the swimming pool office that they are on leave.
- B. Badges: All identification badges must be kept year to year. Service charge of \$30 for replacement of an I.D. Badge.

- C. In addition to full season membership in the Paramus Pool, the nonrefundable fee for the registration to join the swim/dive lessons shall be \$100 per person per course.
- D. In addition to full season membership in the Paramus Pool, the nonrefundable fee for the registration to join the swim/dive team shall be \$75. Swim/Dive Team Parent Association dues and swimsuits are an additional fee.

E. Discounts Available:

- Paramus Volunteers (Fire, Rescue, Volunteer Ambulance): 50% off family memberships. (volunteer has to join for family to receive discount) (ID required).
- **Veterans:** 50% off family membership. (veteran has to join for family to receive discount) (proof of veteran status required)
- New Members: 10% off membership.
- **Early Bird:** 10% off membership (Valid until April 15).
- Paramus Borough Employees, Paramus Police, Paramus EMS and Paramus BOE Teachers: 20% off membership. Borough ID or BOE ID required.

*** NO Double discounts will apply. Only one discount will apply per membership ***

§ 395-6 Identification badges.

- A. All members will be issued identification badges which must be shown for admission to the facility and shown upon request by authorized pool personnel.
- B. Identification badges or cards are not transferable.
- C. Illegal transfer of badges or cards or the giving of false information or defacing of identification badges or cards will result in revocation or suspension of membership.
- D. Lost identification badges must be reported to the pool manager immediately and can be replaced by a temporary identification badge, good for one week only. At the end of one week, a new identification badge will be issued at the cost of \$30 and the temporary badge will be returned to the pool office.

§ 395-7 Hours of operation.

The hours of operation of the pools shall be as follows:

- A. Mondays through Fridays: 12:00 noon to 7:00 p.m.
- B. Saturdays: 11:00 a.m. to 7:00 p.m.
- C. Sundays and holidays: 11:00 a.m. to 7:00 p.m.

§ 395-8 Rules and regulations.

Current Pool Rules are on file in the Borough Clerk's office and are also available at the pool office.

Section 2. If any part of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect immediately after passage and publication as provided by law.
