

AN ORDINANCE OF THE CITY OF PARK HILLS, MISSOURI AMENDING
SUBSECTION A OF SECTIONS 250.020, OF THE MUNICIPAL CODE OF
THE CITY OF PARK HILLS, MISSOURI, RELATING TO PARK FEES

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARK HILLS, MISSOURI, AS
FOLLOWS:

Section 1. Amending Subsection A of Section 250.020 "Park Fees."

Subsection A of Section 250.020 "Park Fees" of the Municipal Code of the City of Park Hills, Missouri is hereby repealed and replaced in its entirety by the following new subsection A. as follows:

A. The following fees shall apply to all Parks and Recreation activities:

1. Swimming Pool.

- a. Admission: 13 & up \$5.00; 3-12 \$4.00; 2 & under free.
- b. Pool party: 2 hours \$200.00, plus \$3.00 for each attendee in excess of 25.

2. Soccer.

- a. Player registration fee: \$28.00.
- b. Referee per game fee: \$15.00.

3. Softball Leagues.

- a. Men's league: \$190.00.
- b. Co-ed league: \$215.00.
- c. All league registration fees include a refundable forfeit fee of \$56.00.
- d. 14U/16U/18U girls fast pitch: \$210.00. Registration fee includes a refundable forfeit fee of \$70.00.
- e. Ball field rental for tournament: \$50.00 per day per field.

4. Code Enforcement fee schedule with a 1-hour minimum fee and charged at 30-minute increments thereafter.

- i. Backhoe, brush hog, skid steer, garbage truck, dump truck, high lift, bucket truck, or similar equipment: Each----- \$100 per hour.
- ii. Mowers, trucks and trailers. Each-----\$75 per hour.
- iii. Chainsaw, limb saw, weed eater. Each-----\$50 per hour.
- iv. Cleanup (trash pickup, blower use, labor). Each person-----\$25 per hour.

v. Administrative fee.-----\$30 per job.

Section 2. Codification.

It is the intention of the City Council of the City of Park Hills, St. Francois County, Missouri, and it is hereby provided, that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City of Park Hills, Missouri; that the sections of this ordinance may be renumbered or re-lettered to accomplish such intention; and the words "ordinance" may be changed to "section," "article" or other appropriate designation.

Section 3. Effective Date.

This ordinance shall be in full force and effect from and after its passage and approval by the City Council and approval by the Mayor of the City of Park Hills, Missouri, or as otherwise provided by law.
