ORDINANCE NO. 1593-24

AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE QUALIFIED VOTERS OF THE CITY OF PARK HILLS, MISSOURI, AT THE ELECTION TO BE HELD NOVEMBER 5, 2024, OF A PROPOSAL TO APPROVE A ONE QUARTER CENT SALES TAX FOR THE PURPOSE OF PROVIDING REVENUES FOR THE OPERATION OF THE FIRE DEPARTMENT

WHEREAS, Section 321.242 of the Revised Statutes of the State of Missouri authorizes municipalities to impose up to a one quarter (1/4) cent sales tax to provide revenues for the operation of a municipal fire department; and

WHEREAS, the sales tax cannot become effective until approved by the voters at a county or state general, primary or special election.

WHEREAS the City of Park Hills, Missouri did previous pass a one quarter (1/4) cent sales tax for the period of ten (10) years ending March 2025 for the purpose of providing revenues for the operation of the Park Hills' Fire Department.

WHEREAS the City of Park Hills, Missouri desires to submit the matter to the voters for the continuation of said sales tax.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARK HILLS, MISSOURI, AS FOLLOWS:

SECTION 1.

The City Council does hereby call an election to be held November 5, 2024, at which time there shall be submitted to the registered voters of the city of Park Hills a proposal to approve a one quarter (1/4) cent sales tax for the purpose of providing continued revenues for the operation of the fire department and the official ballot to be supplied and used at said election shall be in substantially the following form:

PROPOSITION A

Shall the City of Park Hills impose a sales tax of one fourth (1/4) of one percent for the purpose of providing continued revenues for the operation of the City of Park Hills Fire Department? If this proposition is approved, the City of Park Hills' sales tax will remain unchanged.
