## AN AMENDED ORDINANCE OF THE CITY OF PARK HILLS, MISSOURI, AUTHORIZING THE CITY ADMINISTRATOR TO APPLY FOR A COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)

WHEREAS, Missouri Department of Economic Development is taking applications for a Community Development Block Grant (CDBG). CDBG is a Missouri department of Economic Development program and is designed to support the community's wellbeing and greater capacity for growth. Grants are available in a variety of categories and can be utilized for a variety of community development initiatives.

WHEREAS, the City of Park Hills desires to apply for a CDBG grant in the amount of \$624,181.00 for street improvements split between \$500,000.00 for construction and \$124,181.00 for engineering and grant administration. The City has also committed \$10,000 local cash and \$10,000 in kind of the form of labor.

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARK HILLS, MISSOURI, AS FOLLOWS:

Section 1. <u>CDBG GRANT APPLICATION</u>. The Park Hills City Council hereby authorizes the City Administrator or designated agents to proceed with the application for a Community Development Block Grant (CDBG). The City Administrator is further directed to bring any successful application or proposed CDBG agreement to the City Council for their review, consideration and approval. As part of said application, the City Administrator or designated agents are hereby authorized to commit \$10,000 local cash and \$10,000 in kind of the form of labor.

Section 2. <u>Authorizations</u>. The Mayor, City Administrator and/or any other necessary employees are hereby authorized to execute said CDBG application for said grant and any other necessary documents to carry out the intent of the agreement; and the City Clerk is hereby authorized to attest any such signatures on any such documents and to affix the City's seal thereto to the extent required by such documents. All officials and employees of the City are authorized and empowered, collectively or individually, to take all other actions and steps and to execute all instruments, documents, agreements and contracts on behalf of the City as they shall deem necessary or desirable in connection with the CDBG application and the carrying out of the intention of this Ordinance.

Section 4. <u>Severability</u>. The portions of this Ordinance shall be severable. In the event that any portion of this Ordinance is found by a court of competent jurisdiction to be invalid, the remaining portions of this Ordinance are valid, unless the court finds the valid portions of this Ordinance are so essential and inseparably connected with and dependent upon the void portion that it cannot be presumed that the City Council would have enacted the valid portions without the invalid ones, or unless the court finds that the valid portions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.

Section 5. Effective Date. This Ordinance shall take effect immediately.
