AN ORDINANCE ESTABLISHING THE ANNUAL RATE OF TAX LEVY FOR THE YEAR 2021 ON ALL PROPERTY WITHIN THE CITY OF PASADENA HILLS, MISSOURI, PROVIDING FOR THE EXTENSION OF SAID TAXES ON THE BOOKS OF THE COLLECTOR BY THE ST. LOUIS COUNTY CLERK AND PROVIDING FOR THE COLLECTION THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PASADENA HILLS, MISSOURI, AS FOLLOWS:

**SECTION ONE:** There is hereby levied on all residential real property, within the corporate limits of the City of Pasadena Hills, Missouri for the year 2021, as a rate of \$.2190, on one hundred dollars (\$100.00), of assessed valuation as shown on the assessment books of the County of St. Louis, as corrected or amended by the Board of Equalization and certified to by the County Clerk.

**SECTION TWO:** There is hereby levied on all commercial property, within the corporate limits of the City of Pasadena Hills, Missouri, for the year 2021, at a rate of \$.1020, on one hundred dollars (\$100.00), of assessed valuation as shown on the assessment books of the County of St. Louis, as corrected or amended by the Board of Equalization and certified by the County Clerk.

**SECTION THREE:** There is hereby levied on all personal property, within the corporate limits of the City of Pasadena Hills, Missouri, for the year 2021 at a rate of \$.3100, on one hundred dollars (\$100.00), of assessed valuation as shown on the assessment books of the County of St. Louis, as corrected or amended by the Board of Equalization and certified to by the County Clerk.

<u>SECTION FOUR:</u> There is hereby levied additionally for debt service purposes on all real estate and personal property, within the corporate limits of the City of Pasadena Hills, Missouri, for the year 2021 at a rate of \$.7050, on one hundred dollars (\$100.00), of assessed valuation as shown on the assessment books of the County of St. Louis, as corrected or amended by the Board of Equalization and certified to by the County Clerk.

**SECTION FIVE:** The Clerk of St. Louis County, Missouri is hereby authorized to extend on the books of the Collector the amount of taxes due and collectible according to the above rates on all real and personal property, within the corporate limits of the City of Pasadena Hills, Missouri.

**SECTION SIX:** This ordinance repeals all previous Ordinances of like subject matter in its entirety.

<u>SECTION SEVEN:</u> This ordinance shall be in full force and effect from and after its passage and approval by the Board of Aldermen and the Mayor.
