**AN ORDINANCE OF THE CITY OF PERTH AMBOY, COUNTY OF MIDDLESEX, NEW JERSEY AMENDING AN ORDINANCE ENTITLED "AN ORDINANCE DESIGNATING RESTRICTED PARKING SPACES FOR USE BY HANDICAPPED PERSONS" (ORDINANCE NO. 380-85 AND AMENDMENTS) ADOPTED JULY 2, 1985 ALSO KNOWN AS CHAPTER 255A ET SEQ OF THE CODE OF THE CITY OF PERTH AMBOY**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERTH AMBOY IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY:**

**SECTION 1.** That Section 255A-2 Residential handicapped parking spaces is amended as follows:

**ADDITIONS:**

456 Compton Avenue  
Northerly Side

Beginning at a point 277 feet west of the curb line of Cornell Street extending to a point 25 feet west thereof

859 State Street  
Westerly Side

Beginning at a point 807 feet north of the curb line of Pulaski Avenue extending to a point 24 feet north thereof

**DELETIONS:**

296 Jeffries Street  
Westerly Side

Beginning at a point 220 feet north of the curb line of Penn Street extending to a point 22 feet west thereof

366 Jeffries Street  
Northerly Side

Beginning at a point 109 feet west of the curb line of Jacques Street extending to a point 22 feet west thereof

378 Jeffries Street  
Northerly Side

Beginning at a point 338 feet east of the curb line of Amboy Avenue extending to a point 22 feet east thereof

190 A-3 Madison Avenue  
Easterly Side

Beginning at a point 120 feet south of the curb line of Gordon Street extending to a point 22 feet south thereof

343 Market Street  
Southerly Side

Beginning at a point 41 feet west of the curb line of Olive Street extending to a point 22 feet west thereof

455 Mechanic Street

Beginning at a point 25 feet west

Southerly Side (Corner DeKalb Ave.)	of the curb line of Mechanic Street extending point 22 feet west thereof
<u>355 Neville Street</u> Southerly Side	Beginning at a point 260 feet east of the curb line of Amboy Avenue extending to a point 22 feet east thereof
<u>413 Neville Street</u> Southerly Side	Beginning at a point 50 feet east of the curb line of Cornell Street extending to a point 22 feet east thereof
<u>492 Neville Street</u> Northerly Side	Beginning at a point 211 feet west of the curb line of Groom Street extending to a point 22 feet west thereof
<u>496 Neville Street</u> Northerly Side	Beginning at a point 240 feet west of the curb line of Groom Street extending to a point 25 feet west thereof
<u>538 Sayre Avenue</u> Westerly Side (Corner west side of Steadman Pl. for rear entrance)	Beginning at a point 56 feet north of the curb line of Sayre Avenue extending to a point 25 feet north thereof
<u>240 Second Street</u> Easterly Side	Beginning at a point 78 feet south of the curb line of Market Street extending to a point 22 feet south thereof
<u>534 South Park Drive</u> Northerly Side	Beginning at a point 408 feet east of the curb line of Convery Boulevard extending to a point 22 feet east thereof
<u>363 Stanford Street</u> Westerly Side	Beginning at a point 58 feet south of the curb line of Lehigh Avenue extending to a point 22 feet south thereof
<u>104 State Street</u> Easterly Side	Beginning at a point 203 feet north of the curb line of Lewis Street extending to a point 22 feet north thereof
<u>159 State Street</u> Westerly Side	Beginning at a point 164 feet north of the curb line of Patterson Street extending to a point 22 feet north thereof
<u>383 Summit Avenue</u> Southerly Side	Beginning at a point 25 feet east of the curb line of Pine Street extending to a point 22 feet east thereof

<u>364 Sutton Street</u> Northerly Side	Beginning at a point 136 feet west of the curb line of Jacques Street extending to a point 22 feet west thereof
<u>350 Thomas Street</u> Northerly Side	Beginning at a point 186 feet west of the curb line of Francis Street extending to a point 22 feet west thereof
<u>103 Washington Street</u> Southerly Side	Beginning at a point 168 feet east of the curb line of State Street extending to a point 22 feet east thereof
<u>193 Washington Street</u> Southerly Side	Beginning at a point 110 feet east of the curb line of Park Avenue extending to a point 22 feet east thereof
<u>272 Washington Street</u> Northerly Side	Beginning at a point 85 feet east of the curb line of Penn Street extending to a point 22 feet east thereof
<u>328 Washington Street</u> (Corner sign will be on Johnstone Street)	Beginning at a point 50 feet north of the curb line of Washington Street extending to a point 22 feet north thereof
<u>398 Washington Street</u> Northerly Side	Beginning at a point 106 feet east of the curb line of Cornell Street extending to a point 22 feet east thereof
<u>168 Water Street</u> Easterly Side	Beginning at a point 431 feet south of the curb line of Gordon Street extending to a point 22 feet south thereof
<u>263 Watson Avenue</u> Westerly Side	Beginning at a point 143 feet north of the curb line of Market Street extending to a point 22 feet north thereof

**SECTION 2.** The foregoing Recitals of this Ordinance are hereby incorporated as if set forth at length.

**SECTION 3.** All ordinances or part of ordinances inconsistent with or in conflict with this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4.** The provisions of this Ordinance are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses or phrases of this Ordinance, but they shall remain in effect, it being the

legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

**SECTION 5.** This Ordinance shall take effect immediately upon passage, publication and approval according to law.
