ORDINANCE NO. 2-2.024

AN ORDINANCE AMENDING SECTION 104-12.1, <u>PARKING PROHIBITED DURING CERTAIN HOURS AT</u> <u>ALL TIMES OF ARTICLE III, PARKING REGULATIONS</u>, OF CHAPTER 104, <u>VEHICLES AND TRAFFIC</u>, OF THE CODE OF THE BOROUGH OF PENNSBURG, AS AMENDED, TO PROHIBIT PARKING ON A CERTAIN PORTION OF FOURTH STREET AT CERTAIN TIMES.

NOW, THEREFORE, BE IT AND IT IS HEREBY ENACTED AND ORDAINED

by Pennsburg Borough Council, Montgomery County, Pennsylvania, and it is hereby enacted and ordained by the authority of same as follows:

<u>SECTION 1.</u> Section 104-12.1, <u>Parking Prohibited in Certain Locations at Certain</u> <u>Times</u>, of Article III, <u>Parking Regulations</u>, of Chapter 104, <u>Vehicles and Traffic</u>, of the Code of the Borough of Pennsburg, as amended, is hereby amended to prohibit parking Monday through Friday at 7:00 a.m. to 5:00 p.m. on the following portion of 4th Street:

Name of Street	Side	Location
Fourth Street	South Only	Between 211' East of Dotts ending 265' East of Dotts.

SECTION 2. Section 104-12.1, <u>Parking Prohibited in Certain Locations at Certain</u> Times, of Article III, <u>Parking Regulations</u>, of Chapter 104, <u>Vehicles and Traffic</u>, of the Code of the Borough of Pennsburg, as amended, is hereby amended to prohibit parking and permitting a loading zone only Monday through Friday at 7:00 a.m. to 5:00 p.m. on the following portion of 4th Street:

Name of Street	Side	Location
Fourth Street	South Only	Between 211' East of Dotts ending 265' East of Dotts.

SECTION 3. Ordinance No. 3-2013 enacted on June 4, 2013 shall be deemed rescinded effective the date of the enactment of this Ordinance.

SECTION 4. The remaining provisions of Chapter 104, <u>Vehicles and Traffic</u>, of the Code of the Borough of Pennsburg, as amended, to the extent not inconsistent herewith, are hereby reenacted and re-ordained.

SECTION 5. Any section, article, or clause of Chapter 104, <u>Vehicles and Traffic</u>, which is inconsistent herewith, is hereby repealed.

SECTION 6. This ordinance shall become effective immediately upon enactment.
