AN ORDINANCE AMENDING CHAPTER 382-6 OF THE CODE OF THE BOROUGH OF PENNS GROVE ENTITLED "LEAVES AND GRASS CLIPPINGS"

NOW THEREFORE BE IT ORDAINED that Chapter 382-6 shall be amended to add the following:

F.

Leaves accumulating upon residential properties during the autumn exfoliation shall be bagged free of trash, branches, grass clippings or garbage in either compostable paper bags or in a reusable container without lid for collection in accordance with a schedule to be established annually.

G.

Leaves shall not be set at curbside in such a manner so as not to be confused with routine trash or garbage placed at curbside for collection on designated days.

H.

Leaves collected shall be delivered and disposed of in accordance with law and rules and regulations set forth by the Borough of Penns Grove and any other County authority having control over the disposal of leaves, and in compliance with the County Recycling Plan.

ļ.

The provisions of § 382-20, Violations and penalties, of the Code of the Borough of Penns Grove shall apply to these rules and regulations.

SECTION 1: All Ordinances of parts of Ordinances inconsistent with any of the terms of this Ordinance are hereby repealed to the extent of such inconsistency or inconsistencies.

SECTION 2: This Ordinance shall take effect immediately upon its final passage and publication, as provided by law.
