AN ORDINANCE FIXING THE TAX RATE FOR THE YEAR 2023 IN THE CITY OF PEVELY, MISSOURI, WHEN PAYABLE, AND TO WHOM PAID

WHEREAS, the Pevely Board of Alderman held a duly advertised public Hearing for the purpose of discussing the proposed tax rate on September 18, 2023

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PEVELY, MISSOURI, AS FOLLOWS:

<u>Section 1</u>. For the support of the city government, the advancement of the public interest, and the improvement of the City of Pevely, Missouri, a tax shall be levied on all real estate and personal property within the City of Pevely, Missouri for the year 2023

<u>Section 2</u>. In accordance with the provisions of section 67.110 of the revised Statutes of Missouri, the annual rate of levy shall be the sum of eighty-five and twenty-three one hundredths of a cent (0.8534) per one hundred dollars (\$100.00) assessed valuation

<u>Section 3</u>. The City Clerk of the City of Pevely, Missouri shall prepare appropriate and accurate tax books for assessment books prepared by the Jefferson County Assessor on all property within the City subject to taxation by the State of Missouri, and shall, on or before the 1st of October 2023, transmit same to the Jefferson County Collector and shall charge the Collector with the full amount of taxes levied and to be collected.

<u>Section 4</u>. The Jefferson County Collector shall collect all taxes according to the books prepared and delivered to them by the City Clerk and shall pay the same to the Jefferson County Collector into the County's Treasury each week. The Collector shall provide the City Clerk with monthly reports detailing the quantity of taxes collected.

<u>Section 5</u>. Taxes shall be delinquent on the first day of January 2024 and collection thereof shall be made in the manner provided by Missouri State law and the Jefferson County Collector.


<u>Section 6</u>. This Ordinance shall be in full force and effect from and after the date of its passage and approval.


