### A Local Law "Establishing a Mortarium on Campground developments in the Town of Phelps"

Be it enacted by the **Town Board** (Name of Legislative Body)

County City **Town** of **Phelps** Village

as follows:

Section 1. PURPOSE:

Pursuant to the statutory and common law power vested in the Town of Phelps (the Town") to regulate and control land uses and to protect the health, safety and welfare of its residents, the Town Board of the Town of Phelps herby declares a temporary, six (6) month moratorium on the acceptance, processing or approval of applications for building permits, special use permits, variances, site plans, subdivisions or planned developments related to the undertaking, establishment, placement, development, excavation, enlargement, construction or erection of Campgrounds in the Town.

The objective of this moratorium is to allow the Town sufficient time to investigate and Understand the Act, review the Towns existing laws pertaining to Campgrounds, to recommend any necessary modifications to local laws and/or to recommend the adoption of any local laws. During the moratorium, the Town Board will consider how to best permit campgrounds so as to harmoniously integrate them with the existing communities. If the Town allow such development during the time, it could undermine or damage the state goals in the Town of Phelps Zoning Law and or the Town of Phelps Comprehensive Plan and related legislation to protect the Town.

#### Section 2. DEFINITIONS

Paragraph B. of Section 145-4 (Word usage; definitions) of the Town of Phelps Zoning Ordinance is hereby amended to add the following definitions:

A. Campground: This term shall bear the same meaning that is defined in 10 NYCRR Part 7, Subpart 7-3, as currently in effect and as hereafter amended from time to time.

#### Section 3. MORATORIUM

- A. The Town Board hereby enacts a moratorium, which shall prohibit the review, approval, creation, undertaking, establishment, placement, development, excavation, relocation, construction, reconstruction, enlargement, modification or erection of an Campgrounds anywhere within the Town.
- B. This moratorium shall be in effect for a period of six (6) months from the effective date of this Local Law and shall expire on the earlier of (i) the date six (6) months from said effective date unless renewed; or (ii) the enactment by the Town Board of a resolution indicating the Town Board is satisfied that the need for the moratorium no longer exists.
- C. The Moratorium shall apply to all zoning districts and all real property within the Town.
- D. Pursuant to this moratorium, the Planning Board shall not review any applications for any Campgrounds nor shall it grant any preliminary or final approval to any special use permit, site plan or subdivision application that includes a Campground as part of the application; except that reviews of existing special use permits that are required to come regularly before the Town for re-approval;, may be reviewed and approved by the Town, provided such applications do no request any modifications to an existing Campground.
- E. Pursuant to the moratorium, the Code Enforcement Officer shall not issue Building permits, or Certificates of Occupancy for any campground anywhere within the Town, except that this moratorium shall not apply to certificates of occupancy for any and all construction pursuant to the building permits issued prior to the effective date of this Local Law or the issuance of any building permit for the renovation or repair of any lawfully existing structure otherwise covered by the Local Law.
- F. Pursuant to the moratorium, the Zoning Board of Appeals shall not review, process or grant any applications for variances that involve the creation, undertaking, establishment, placement, development, excavation, relocation, construction, reconstruction, enlargement, modification or erection of any Campground.

This local law shall take effect immediately upon filing with the Secretary of State.
